Description

The Department of *Economics* at Università Ca' Foscari Venezia invites applications for nr. 2 fellowships in:

• Title:

Banking transformation, bank jobs, and firms

- Academic Discipline or disciplines specifically identified by the call: SECS P/02, SECS-P/11, SECS-P/01
- Scientific coordinator and tutor: Prof. Stefano Colonnello
- Abstract:

Banks, besides being crucial in channeling finance to firms, are important employers, especially for mid-to-high skill workers. But momentous challenges loom in front of banks, like the rise of FinTech and increasingly stringent regulation. On the one hand, these trends jeopardize banks and their workers' careers. On the other, the very same trends make banks less attractive for highly talented labor relative toother sectors. Forced and voluntary attrition of banks' employees is likely to have ramifications for the real side of the economy, as (personal) lending relationships with firms get severed. In such circumstances, smaller, bankdependent firms may find it difficult to tap alternative sources of finance. Whereas the decline of banks is not inescapable, it is of primary importance to characterize their transformation. Using the European financial system as a laboratory, we aim to systematically examine the relation between the current disruption in the banking sector and the real economy, putting the evolving nature of banks' labor at center stage. The goal is to advance knowledge on the human capital dimension of banks' specialness for the economy as well as on the consequences of displacement and redeployment of mid-to-high skill workers. We will undertake an anatomy of banking transformation, to then study its consequences for bank workers' career trajectories and borrowing firms' policies.

Who can apply

Prospective candidates are expected to hold a master's degree in the subjects of the research, or related disciplines.

Favoured headlines

- PhD related to the research activities described in the abstract;
- the completion of attendance at a doctoral course while awaiting conferment of the degree and with the subject of the Announcement.
- Knowledge of microeconometric methods and software (especially Stata) and experience with administrative databases

Evaluation

Up to 100 points, specifically: For qualifications, publications and possible tests, from 0 to 60; For interview, from 0 to 40.

Selection procedure

The interview will be on 2023.10.18, at 09.00 AM.

The interview will be held in remote only. Further details on how to connect online will be published alongside the convocation notice.

The **interview** will take place in English and it will focus on knowledge of the following topics:

- assessment of the candidate's motivation and his/her skills in the thematic areas covered by the PRIN Project.

Modalities for monitoring and evaluating the activity carried out by check holders

At the end of the period of duration of the grant and in any case at the end of each year, in the case of multi-year grants, the researcher is required to submit to the structure a written report on the research activity carried out.

At the end of the research activity, the researcher must provide the department with the following scientific products that define a "minimum standard of result":

- one or more working papers in English on the topic of the PRIN Project.
