Description

The Department of Humanities at Ca' Foscari University of Venice (Dipartimento di Studi Umanistici dell'Università Ca' Foscari Venezia) invites applications for a fellowship in: "The theoretical debate on *The Ethical Turn*", Academic discipline: L-FIL-LET/14 Literary criticism and comparative literature, duration 15 months, tutor Dr. Domenico Cangiano, financed by the PRIN 2022 project "Obscene Freedom. Libertinism and Radical Enlightenment in Contemporary Fiction and Imagery" (codice progetto 20228Z92FK), CUP: H53D23006690006, Head of Unit Dr. Domenico Cangiano.

Abstract: The research is part of the PRIN project titled "Obscene Freedom. Libertinism and Radical Enlightenment in Contemporary Fiction and Imagery", a project aimed at analyzing the role of the libertine and radical tradition of the Enlightenment in contemporary literature, and in contraposition to the so-called *Ethical Turn*.

Ca' Foscari research unit will focus on the most theoretical side of the project, analyzing both the critical and public debate. We will take into consideration not only the English-speaking area but also the Italian (Siti, Raimo, Murgia, etc.) and French contexts (recently Macron labeled political correctness as a "non-French thought").

The goal is to realize an accurate and methodologically precise map of the positions of the numerous contexts in order to better understand the effects of the ethical turn on the fortune of libertinism and the radical Enlightenment in contemporary literature and current imaginaries.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Ca' Foscari University of Venice.

Who can apply

Prospective candidates are expected to hold a PhD and a suitable scientific / professional track record.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar. Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

Duration of contract: 15 months (approximate starting date: 1st December 2023)

Stipend: The research fellowship amounts to 24,208.75 Euros, including taxes and social charges.

Deadline for submission of applications: 20th October 2023, h. 12.00 noon (Italian time).

Evaluation

Up to 100 points, specifically: For qualifications, publications and possible tests, from 0 to 60; For interview, from 0 to 40.

The following qualifications are considered as evaluation criteria:

- a) list of publications;
- b) specialization diplomas and attendance certificates at post-graduate specialization courses, obtained both in Italy or abroad, documented research activity in public and private organizations with contracts, study grants or assignments both in Italy and abroad;
- c) Documented organization of seminars and events (for example symposiums) organized in academia (the organization of a bimonthly series of seminars will be one of the main duties of the winner of the postdoc).

- d) attached 'preferential securities', if the candidate possesses them see Article 5 of the competition available in Italian (link);
- e) any other element provided for the announcement, to the articles 2, 3 and 5 of the competition available in Italian (link).

The interview aims to assess the candidates' skills and expertise on the following subjects:

- Excellent knowledge of the debates on the Ethical Turn and on the Culture Wars;
- Good knowledge of contemporary Western literature;
- Knowledge of the English language.

At the end of his/her research activity, the research fellow is required to provide the Department with:

- A final report on the activities carried out, highlighting the achievements.
- A "research history" that, written in a non-specialist language and enriched by pictures of the activities carried out, show the results achieved and can be used for disseminating the research topic
- Dissemination of the results achieved, also through public presentations.
