Research fellowship on "The Language of Innovation" - Università Ca' Foscari Venezia (Italian law 30 December 2010, n. 240, art. 22 and subsequent amendments and additions).

Description

The Department of Management at Università Ca' Foscari Venezia invites application for one-year fellowship in **The Language of Innovation**, under the supervision of prof. Giulia Cancellieri (SSD SECS-P/08 – Management).

Project acronym: PRIN 2022 "The Language of Innovation" n. 2022MCWT4Y - CUP H53D23002520001

Abstract: When is novelty more likely to elicit support from relevant audiences? Innovators' struggle to rally key audiences' support around their novel ideas, products, or projects is a central theme in the innovation and entrepreneurship literature. In this project we tackle this question by adopting a linguistic view on innovation. Indeed, despite the frequency with which audiences across innovation domains are expected to evaluate novel offers couched into carefully crafted communication efforts, little research exists that attends to the structural properties of such messages and their effect on the recipients' evaluative responses. Addressing this shortcoming implies to zoom in on the language that innovators use and the effect this has on their endeavours to marshal symbolic as well as material resources. More specifically, we ask:

- How do successful innovators frame their ideas to maximize impact?
- What linguistic properties should be mobilized by innovators to rally support for their endeavors from key audiences (investors, the crowd, customers, etc.)?
- What framing strategies are more appropriate for incremental as opposed to radical ideas?
- Is abstract or concrete communication more effective in conveying an idea's potential to a particular audience?

Drawing on language-oriented scholarship, social psychology, and cultural entrepreneurship the project explores a variety of linguistic features that entrepreneurs can mobilize to obtain the support of their audience.

The research may be carried out in Italian and English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

Who can apply

Prospective candidates are expected to hold a master's degree or equivalent degrees and scientificprofessional curriculum suitable to the development of research activities related to the fellowship.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar.

Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

Duration of contract: 12 months (approximately starting: February 2024), with the possibility of renewal within the limits of art. 2 of the Regulations on university research fellowship awarding, which will be subject to a specific contract.

Stipend: The research fellowship amounts to **19.456,00** *Euros*, including taxes and social charges depending on applicant's filing status (cost to Ca' Foscari € 24.000,00).

Deadline for submission of applications: January 09th 2024, 12 noon (Italian time).

How to apply:

Candidates shall submit:

- 2. A motivation letter (max 1 page) along with their CV in European format, duly dated and signed, both to enclosed as a one single.pdf file (<u>link</u>); a declaration must be appended in the footnote of the curriculum,









pursuant to the Italian DPR 445/2000 and subsequent amendments and additions, that the information provided corresponds to the truth. Moreover the candidates have to consent to the use of their personal data for the purposes of this selection procedure pursuant to the Italian Legislative Decree 196/2003 and to the EU Regulations 2016/679;

Evaluation

The evaluation takes into account the criteria and thresholds described in the table below.
