





### Research fellowship on "Multimodality in the Babylonian Cadastral Maps: form, function and lexicon" – Department of Humanities Ca' Foscari University of Venice

### Description

The Department of Humanities at Ca' Foscari University of Venice invites applications for a fellowship in: **"Multimodality in the Babylonian Cadastral Maps: form, function and lexicon", Academic discipline: L-OR/03 Assiriology, duration 23 months, tutor prof. Paola CORÒ**, financed by the PRIN 2022 PNRR -Missione 4 "Istruzione e Ricerca" del Piano Nazionale di Ripresa e Resilienza ed in particolare la componente C2 – investimento 1.1, Fondo per il Programma Nazionale di Ricerca e Progetti di Rilevante Interesse Nazionale (PRIN), project "Mapping and Annotating Plots (MAP): the Multimodality of Cadastral Plans in Antiquity (Babylonia and Rome)" (codice progetto P2022SH5BM), CUP: H53D23010270001, Principal Investigator prof. Paola CORÒ.

### Abstract

The research develops in the framework of the MUR PRIN 2022 PNRR project P2022SH5BM - Mapping and Annotating Plots (MAP): the Multimodality of Cadastral Plans in Antiquity (Babylonia and Rome), which aims at exploring annotated maps through the lens of multimodality, whose potential for a better understanding of the mechanisms and procedures underpinning the production of this documentary class and the administrative context whence they stem will be tested here for the first time. Babylonian Cadastral maps are the object of the research carried out by the Venice unit of the project. Supervised by the PI, the candidate is expected to contribute to collect the evidence and help in the re-edition of relevant materials (Late-Babylonian filed plans); study the level of the literacy, accuracy, and know-how of the scribes/surveyors who produced cadastral maps on the basis of paleography, epigraphic indicators and the study of the multimodal characteristics of the texts; map the lexicon used, also in connected documents and actively contribute to the project's life in all its aspects (meeting, brainstorming, dissemination, publications).

The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Ca' Foscari University of Venice.

Prospective candidates are expected to hold a master's degree with dissertation in Assyriology and a suitable scientific / professional track record demonstrating the candidate's familiarity with 1st mill B.C. documents

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar. # Evaluation

Up to 100 points, specifically: For qualifications, publications and possible tests, from 0 to 60; For interview, from 0 to 40.

The following qualifications are considered as evaluation criteria:

- a) PhD or completion of a PhD pending title (with dissertation consistent with SSD L-OR/03)
- b) list of publications consistent with SSD L-OR/03;
- c) electronic submission of a maximum of 3 publications consistent with SSD L-OR/03 (in PDF format);
- d) Post-graduate degree and post-graduate training certificates obtained in Italy or abroad;









performance of documented research activities with public or private entities with contracts, scholarships or assignments, in Italy or abroad, with particular reference to SSD L-OR/03;

- e) attached 'preferential securities', if the candidate possesses them see Article 5 of the competition available in Italian (link);
- f) any other element provided for the announcement, to the articles 2, 3 and 5 of the competition available in Italian (link).

The interview aims to assess the candidates' skills and expertise on the following subjects:

- Knowledge of the problematics related to Late-Babylonian documents;
- Knowledge of Akkadian;
- Knowledge of English language.

At the end of his/her research activity, the research fellow is required to provide the Department with:

- Text editions;
- Input of data for the construction of the digital platform;
- One article on a project-related topic;
- Participation in dissemination activities.
