Research fellowship on Narratives, symbols and imaginaries of (in)equality in Southeast Asia (Thailand and/or Myanmar) - Università Ca' Foscari Venezia

Description

The Department of Asian and North African Studies at Università Ca' Foscari Venezia invites applications for a fellowship in:

- **Title:** Narratives, symbols and imaginaries of (in)equality in Southeast Asia (Thailand and/or Myanmar)

- Abstract:

The project is part of the PRIN project "SISEA - Symbolic inequality at work: gendered exclusion and imaginaries of empowerment in Southeast Asia", conducted by the Department of African and Mediterranean Asian Studies (DSAAM) jointly with the units of research at the University of Milano-Bicocca and Napoli "L'Orientale".

This multidisciplinary research shall explore practices and imaginaries of inequality in Southeast Asia through the lenses of gender, labour and ethnicity. The project aims to investigates the multiple processes that underpin the acceptance, enforcement and/or the upturning of growing structures of existential inequality in the world from a Southeast Asian standpoint. The project will draw on detailed bottom up analyses and ethnographic research on how the three main social constructs of gender, labour and ethnicity are effective in creating, maintaining or dismantling inequality in specific situations of marginality in a number of Southeast Asia's locales.

Candidates must have a background that lies at the intersection of Southeast Asian studies, anthropology, sociology, religious studies, political science, or related fields, and in the empirical/ethnographic study of contemporary **Thailand and/or Myanmar**, wishing to undertake a research project in the area of Southeast Asian Studies.

The fellow will work under the direction of a SISEA's scientific supervisor, with the expectation that he will contribute to the advancement of the aforementioned project, through the development of his/her own research ideas/adaptation and development of research protocols. It will be **required a period of fieldwork in Thailand**.

The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

Who can apply

Prospective candidates are expected to hold a master's degree and a CV suitable for the requested research activities.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar. Evaluation

Up to 100 points, specifically: For qualifications, publications and possible tests, from 0 to 60; For interview, from 0 to 40.
