

Research fellowship on "Returning Foreign Fighters. The Demobilisation of Italian Transnational War Volunteers in Liberal Italy" – Department of Humanities Ca' Foscari University of Venice

### Description

The Department of Humanities at Ca' Foscari University of Venice invites applications for a fellowship in: Returning Foreign Fighters. The Demobilisation of Italian Transnational War Volunteers in Liberal Italy, Academic discipline: M-STO/04 Contemporary history, duration 12 months, tutor Prof. Elena BACCHIN, financed by the PRIN 2022 PNRR project "P202278HMH - Returning Foreign Fighters (ReFF). The Demobilisation of Italian Transnational War Volunteers, 1860s-1970s", CUP: H53D23010170001, Head of Unit Prof. Elena BACCHIN.

### **Abstract**

The project "Returning Foreign Fighters. The Demobilisation of Italian Transnational War Volunteers, 1860s-1970s", discusses the trajectories, fates, and legacies of Italian foreign fighters who had moved to a state other than their own with the intent to perpetrate, plan and participate in, or support acts of war, or to give or receive military training. The research will focus on Liberal Italy and specifically, it might focus on the 1863-4 Polish Uprising, the 1866-69 Cretan Revolt, the international defense of the Paris Commune, the Greco-Turkish War of 1897, the "Splendid Little War" in Cuba, the Balkan wars, and Italian volunteers in the Argonne in 1914 (before Italy entered the First World War). In particular, it investigates the actions of Italian foreign fighters who returned to their home country to understand whether they demobilized or chose new forms of political mobilisation and to analyse what Italian and international authorities did to monitor and, possibly, contain and repress their actions. The postdoc fellow will carry out research in Italian and foreign archives and libraries with the aim of collecting documentary and printed material relating to the research.

The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Ca' Foscari University of Venice.

Prospective candidates are expected to hold a master's degree and a suitable scientific / professional track record.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar. Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

**Duration of contract:** 12 months (approximate starting date: 15<sup>th</sup> February 2024)

Stipend: The research fellowship amounts to 30,000 Euros, including taxes and social charges.

Deadline for submission of applications: 9th January 2024, h. 12.00 noon (Italian time).

Candidates shall submit:

The candidate, after the uploading, will receive a submission number and an e-mail acknowledging receipt of his/her application.

The candidate if necessary could access the procedures for updating any data and materials by the link provided by the e-mail, in any case any updates must be made no later than the deadline on **9**<sup>th</sup> **January 2024**, h. **12.00 noon (Italian time)**.

Please note that in case of a high number of applications and / or weight of the materials loaded by the candidates the system might become slower, therefore it is suggested not to start the process close to the deadline.

### **Evaluation**

Up to 100 points, specifically: For qualifications, publications and possible tests, from 0 to 60; For interview, from 0 to 40.

The following qualifications are considered as evaluation criteria:

- a) a PhD, or the completion of a PhD course pending graduation;
- b) list of scientific publications;









- c) electronic submission of 3 (three) publications (in PDF format);
- d) specialisation diplomas and attendance certificates at post-graduate specialization courses, obtained both in Italy or abroad, documented research activity in public and private organisations with contracts, study grants or assignments both in Italy and abroad;
- e) attached 'preferential securities', if the candidate possesses them see Article 5 of the competition available in Italian (link);
- f) any other element provided for the announcement, to the articles 2, 3 and 5 of the competition available in Italian (link).

The interview aims to assess the candidates' skills and expertise on the following subjects:

- General knowledge of Italian history and Liberal era;
- Basic knowledge of the secondary literature on the topic and of possible primary sources to be analysed.

At the end of his/her research activity, the research fellow is required to provide the Department with:

- The fellow will be asked to submit an article to an A-level journal and to collaborate with a chapter in the collective book promoted by the research group, as well as carry out dissemination activities of the research results among a non-specialist public.

### Selection procedure

The interview will be **on 23<sup>rd</sup> January 2024, h. 2:00 p.m.** The interview will be held in remote with Google Meet.
