Student	Prior to moving to the Student Dormitory, it is mandatory to submit:
Dormitory	 ID card Medical certificate that there is no contraindication for accommodation in Student Dormitory. Confirmation from home University that student is a full-time student.
	Student will not be allowed to enter the Student Dormitory without ID card and Medical certificate.
	General instructions/information about accommodation in Student Dormitory:
	 Electrical appliances (cookers, irons, etc.) are not allowed in the rooms. Students that are accommodated in Student Dormitory can use a set board (iron and table) free of charge in the laundry room. Students can bring their own computer and connect it to the computer network dorm (wire and wireless). Each student in the room has its own desk and lamp, and each room has a toilet, refrigerator and television. Beds in the Student Dormitory have complete linen (bedsheet), but students can bring their own, if they want to. Students can use the laundry service (washing and drying) within the Student Dormitory by paying tokens: for washing 10,00 Kuna and for drying laundry also 10,00 Kuna. Few important tips: Students needs to bring with themselves the cutlery/dinner set (plate, spoon, fork and knife), cups, glasses and other things that they might need. Within the Student Dormitory, there is a multimedia classroom and gym which students can use free of charge. Kitchenette is located on every floor. Student restaurant (Mensa) is in the proximity of the Student Dormitory. Dormitory front desk is open 24 hours. (*this information is changeable) The price of accommodation is unique per month. For the next academic year, the price still has to be fixed, the last was 900,00 Kuna. You can check currency for every day on the website of the Croatian National Bank. If a student decides to leave Student Dormitory before the final date agreed in the contract between both parties (student and Student Dormitory¹), it is still mandatory to pay for the full rent. 10. Student has right to cancel the reservation for accommodation in Student Dormitory, but it has to be done on time. The deadline for cancelation of accommodation is: autumn semester - to be decided and sent by e-mail to chosen candidates spring semester - to be decided and sent by e-mail to chosen candidates 11. Student restaurant	 The student restaurant is in proximity to the Student Dormitory. Student restaurant is divided into restaurant and pizzeria: Restaurant has working time for: breakfast (Monday-Friday 7:30–9:00, Saturday 8:00-9:00, not in offer on Sunday and holidays); lunch (Monday-Saturday 11:30 – 15:30); dinner (Monday-Saturday 18:00 – 20:00). On Sunday is open just for lunch from 12.00 - 14.00. Pizzeria is working from Monday to Saturday from 11.00 - 20.00. The students will make student x-card, which they can use in the Student restaurant. One lunch (soup, main meal, salad, and dessert) cost 6,50 HR KN (~0,80€). * Working hours may differ due to pandemic covid-19
X-card (student card, official	It is mandatory for every student to make an x-card. X-card is a confirmation that the student has enrolled at Juraj Dobrila University of Pula. With X-card, students will have discounts in Student restaurants, for public transportation, bus ticket, cinema, etc.

	The process of approving the temporary residence is taking around one (1) month and during this time, the student is not recommended to leave the country of residence (we do not guarantee re-entry into the Republic of Croatia because the approval process is ongoing).
	After approving a temporary residence permit in Croatia (for students with not regulated temporary stay in EU country), student is mandatory to pay: 350,00 HR KN – approval of temporary residence permit; 240,00 HR KN – making of ID card for a temporary residence permit; 70,00 HR KN – national landmark; and bring one (1) biometrical picture size 35 x 45 mm.
VAT/OIB number and student x-card for Mensa	Students will receive VAT/OIB number (Personal Identification Number) for Croatia in: - Tax Office Upon arrival, a member from Office for Partnership and Projects will assist in the above-mentioned procedure. With VAT/OIB number, students will go to University Student Office and receive an X card – student card. ²
