Models of strategic interaction under competing cultural frames

Università Ca' Foscari Venezia (Italian law 30 December 2010, n.240, art. 22)

The Department of Management at Università Ca' Foscari Venezia invites applications for a three-year post-doc grant within a 4-year large-scale research program ODYCCEUS -Opinion Dynamics and Cultural Conflict in European Spaces Grant Agreement n. 732942 del 26/10/2016, CUP H72F16000760006 H2020-FETPROACT- 2016-2017 RIA, under the supervision of prof. Marco LiCalzi, Chair of Mathematical Methods for Economics (SECS-S/06).

The successful candidate will contribute towards developing theoretical models for the analysis of strategic interactions when agents process a plurality of games through cultural frames (that is, socially shared representations).

The research shall be carried out in English.

The main expected deliverables include the following.

- 1) Game projections. We lack game-theoretic foundations for enculturated actors, whose behaviour is heavily affected by cultural influences. We aim to model how cultural frames affect agents' understanding and analysis of complex interactions, reducing them to the analysis of simpler "situations".
- 2) Richer models for strategic interactions. Existing models of strategic interaction abstract away from how different cultures and mindsets filter and shape how agents represent mutual interactions, opportunities for acting, and their own intentions. We aim to provide models that address how individual learning, mutual understanding (including its repair after a breakdown), and evolution of culture may take place.
- 3) Conceptual spaces. The literature in cognitive science has developed conceptual spaces to study human processing of categories, text, and actions. We aim to fill a gap and develop an operational formalisation that can be used for a finer-grained representation of how different mindsets frame interaction more or less likely to elicit diverse forms of conflict and cooperation.

# Who can apply:

Prospective candidates are expected to hold a doctoral degree in economics, mathematics, operations research, statistics, or related fields, with a demonstrated research record in at least one of the following areas: (1) game theory, (2) economic theory, (3) organizational economics, (4) network science, and/or (5) mathematical or quantitative methods, with evidence of direct applicability to problems in economics.

**Duration of contract:** 36 months (expected starting date: **June 2017**).

Stipend: The gross fellowship amounts to Eur. 29.400,00 per year. The fellowship is taxexempt, but it is subject to deductions to cover social security and pension benefits, as mandated by the Italian law.

# Deadline for submission of applications: May 15<sup>th</sup> 2017, 12 p.m. (Italian time)

#### **Selection procedure:**

Short-listed candidates will be invited for interview on May 26<sup>th</sup> 2017, at 10 a.m. (italian time) in the Università Ca' Foscari Venezia – Dipartimento di Management, San Giobbe – Cannaregio, 873, Aula Volpato – second floor.

The short list will be published on (link) on May 23<sup>th</sup> 2017.

Candidates living more than 200 Km far from Venice may ask to hold a video interview.
