The Department of Management at Università Ca' Foscari Venezia invites applications for n. 1 fellowships in '*The role of cultural heritage as incubator and accelerator of innovative entrepreneurship*', Project: INTERREG CENTRAL EUROPE SACHE – Smart Accelerators of Cultural Heritage Entrapreneurship – CE1565 - CUP H74I19000360006 – under the supervision of prof. Fabrizio Panozzo SECS-P/07 – Business Administration and Accounting Studies.

The research may be carried out in Italian and English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

Title: The role of cultural heritage as incubator and accelerator of innovative entrepreneurship

Abstract: It is widely expected that culture and heritage automatically inspire innovation and new creative entrepreneurship but research shows that this is rarely the case. It is therefore necessary to challenge and reinterpret the role of cultural and creative industries (CCIs) for regional development. The Interreg Central Europe project will expand and strengthen the role of cultural heritage sites, symbols and values by transforming them into "Smart Accelerators of Creative Heritage Entrepreneurship" (SACHE) based on a newly developed central European model.

The research project builds on the collaborative atmosphere that will be constructed in a preliminary mapping phase. The main objective is to develop a portfolio of value services to promote the Smart Accelerators of Creative Entrepreneurship services, fine tune it and disseminate it. The portfolio is composed of beneficiaries tools and methodologies that would support the practical implementation of business relationships between creative practitioners and cultural institutions. The service portfolio will be addressed to Cultural operators and Institutions, Creative practitioners Intermediaries, high-tech SMEs and public institution in charge of culture promotion. The portfolio development will be carried out thorough engaging, co-creation methods activities and exchange knowledge actions.

Who can apply

Prospective candidates are expected to hold master's degree in Economics for the environment and culture and relevant experience on the research topic and scientific-professional curriculum suitable to the development of research activities related to the fellowship.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar.

Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

Duration of contract: 12 months (approximately starting: January 2020);

Stipend: The research fellowship amounts to 19.367,00 *Euros* per year, including taxes and social charges.

Deadline for submission of applications: December 05th 2019, 12 noon (Italian time).

Evaluation

The total mark of each candidate will be awarded based on 100 total points. The evaluation takes into account the criteria and thresholds described in the table below.
