## Description

The Department of Humanities at Ca' Foscari University of Venice (Dipartimento di Studi Umanistici dell'Università Ca' Foscari Venezia) invites applications for a fellowship in: "From Aquileia to Venice. Harbors, Infrastructures and Productive Areas between Roman Times and Early Middle Ages. An interdisciplinary approach to humans', resources', and the environment's interactions", Academic discipline: L-ANT/07 Classical archaeology, L-ANT/09 Ancient topography, Tutor prof. Diego Calaon, co-tutor prof. Daniela Cottica.

The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

### Abstract

Using archaeological records, the research aims to illustrate the development of sea and lagoon-river ports in connection with the production processes and artisanal activities. The geographic focus is regional (Upper Adriatic) and the chronological accent covers a multiperiod range from Roman Age to Early medieval times. The research starts from two archaeological sites under excavation (Aquileia and Torcello harbors), but it will address the nature of archaeological port infrastructures in the whole coast of Venetia and Histria. Upper Adriatic harbors are favored sites where analyze and define the demographic and the economic dynamics of the area. Studying the transformations both of the material structures and the artisanal/productive configurations related to the harbors will allow the appointed researcher to better understand the intricate correlation between trade systems, production, and communities. The research methods are grounded on the creation of fresh archaeological evidence through excavations, with an emphasis on digital data and GIS approaches.

### Who can apply

Prospective candidates are expected to hold: degree (study course of no less than 4 years, established by the academic regulations prior to the DM of November 3rd 2009, no. 509), specialist degree (art. 3, par. 1, letter b), DM of November 3rd 2009, no. 509), master's degree (art. 3, par. 1, letter b), DM of October 22nd 2004, no. 270) in "**Archaeology**" or equivalent Italian "Classi di Laurea" as "LM-2", "LM-15".and appropriate scientific-professional curriculum for the research.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar. ## Evaluation

Up to 100 points, specifically:

- For qualifications, publications and possible tests, from 0 to 60;
- For the interview, from 0 to 40.

Candidates are admitted to the interview if assessment of the qualifications and the possible tests results in a score equal to or greater than 42/60.

The following qualifications are considered as evaluation criteria:



a) a list of the candidate's scientific publications;

b) holding a PhD in Archaeology or having completed the attendance of a PhD programme, although not having yet obtained the PhD title;

c) specialisation diplomas and attendance certificates at post-graduate specialisation courses, obtained both in Italy or abroad;

d) documented research activity in public and private organisations with contracts, study grants or research fellowships both in Italy and abroad, related to the research topic;

e) certified activities as Site/Sector Director in Archaeological Excavations;

f) certified activities related to the study and digitization of archaeological documentation, archaeological finds, and GIS platform development;

g) attached 'preferential securities', if the candidate possesses them - see Article 5; h) any other element provided for the announcement, to the articles 2, 3 and 5.

The interview aims to assess the candidates' skills and expertise on the following subjects:

- Roman and Early Medieval Harbor System in North Italy: Archaeology and Topography;
- Amphorae from North Italy, 1st-10th cent. AD, types and line of study;
- Aquileia and Torcello, historic and archaeological approach.

At the end of his/her research activity, the research fellow is required to provide the Department with:

- Preparation of the excavation reports and archaeological documentation digitization
- Preparation of 2 scientific articles in peer-reviewed Journals related to the proposed research
- GIS outputs
