#### Description

**Title**: Assessment of potential impacts, vulnerabilities and risks related to climate change in the Veneto coastal area, definition of operational risk assessment methodologies and indicators

Abstract: The research activity contributes to the development of a multidisciplinary approach for the integrated analysis of climate change impacts vulnerability and risk in the Veneto coastal area. The approach will integrate different types of data (e.g. climate projections, chemical-physical, biogeochemical, geomorphological data) available for the pilot area and from the modelling activities carried out by the AdriaClim partner. The resulting output will represent useful information for the development and implementation of the climate change adaptation plan of the Veneto Pilot.

The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

#### Who can apply

Prospective candidates are expected to hold a master's **degree** in **Environmental Sciences** or **Engineering** or **comparable disciplines**.

- Experience in data compilation and handling;
- Proficiency in the use of GIS software (e.g. ArcGis, QGis) and R or/ and Python for spatio-temporal data compilation and handling;
- Experience in applying Machine learning-based Bayesian Belief Networks for multi-scenarios' analysis would be an asset;
- Excellent communication and writing skills in English; Proven track record in publishing scientific results:
- Work experience in interdisciplinary research teams.
