Description

The Department of Management at Università Ca' Foscari Venezia invites application for one-year fellowship in Business-NGO partnerships fostering beneficiaries' empowerment, under the supervision of prof. Francesco Rullani (SECS-P/08 - Management).

Abstract: The research fellowship is part of the Eu-funded REBALANCE project. REBALANCE moves from the observation that large companies are having an ever-greater influence on how democracy is enacted in Europe, leading to a 'market-conforming capitalism'; at the same time, some economic actors are experimenting with alternative models, opening the path to "democracy-conforming capitalism". In this context, the post-doc will conduct (1) a literature review of firms' interconnections leading to misconduct on one side, and on cross-sector partnerships between firms and NGOs on the other side; (2) qualitative analysis will be carried out focusing on one leading case and then multiple cases of socially impactful firm-NGO partnerships, also applying a qualitative network approach, aimed at understanding the nexus of relations driving the cases' outcomes. Finally, (3) if extended for 6 additional months, the post-doc will also contribute to REBALANCE as a whole by elaborating from the partners' inputs on how economic actors can contribute to democratic processes, thus laying the foundations for the REBALANCE Observatory.

The research shall be carried out in english language. The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

Who can apply

Prospective candidates are expected to hold master's degree and relevant experience on the research topic and scientific-professional curriculum suitable to the development of research activities related to the fellowship.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar. Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

Duration of contract: 12 months (approximately starting: **October 2022**). The contract can be renewed for 1 other year, at the end of which it is possible to extend it further for other 6 months.

Stipend: The research fellowship amounts to **22.374,00** *Euros* **per year**, including taxes and social charges depending on applicant's filing status (cost to Ca' Foscari: € 27.600,00).

Deadline for submission of applications: August 25th 2022, 12 noon (Italian time).
