Research fellowship on "Society and environmental change in the western Mediterranean in the first millennium CE" - Università Ca' Foscari Venezia (Italian law 30 December 2010, n. 240, art. 22)

#### Description

The Department of Humanities at Ca' Foscari University of Venice (Dipartimento di Studi Umanistici dell'Università Ca' Foscari Venezia) invites applications for a fellowship in: **"Society and environmental change in the western Mediterranean in the first millennium CE"**, Academic discipline: L-ANT/08 Christian and medieval archaeology, duration 36 months, tutor prof. Helen Foxhall Forbes, financed by the ERC COG project "SSE1K - Science, Society and Environmental Change in the First Millennium CE", Grant Agreement n. 101044437, CUP: H73C22001720006, Principal Investigator Prof. Helen Foxhall Forbes.

**Abstract:** The postdoctoral researcher will be an environmental archaeologist interested in socio-ecological systems. They will carry out original research into the relationships between society and environmental change in the western Mediterranean in the first millennium CE. They will work with existing GIS-linked datasets for central and southern Italy (such as material from the Tiber Valley Project) to undertake macroand micro-level analyses, including producing large-scale models of climate trends and environmental change across the western Mediterranean for the first millennium CE. They will also examine specific casestudy areas to identify patterns relating to relationships between humans and environmental variation.

In addition to preparing their research for publication, the researcher will participate in the various activities of the SSE1K project, including attending team meetings and undertaking dissemination activities (conferences, seminars, workshops) on the project topics.

The motivation letter to be enclosed with the application shall include a proposal of the research that the candidate would aim to undertake during the research position.

## The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Ca' Foscari University of Venice.

The postdoctoral researcher will work with existing GIS-linked datasets for central and southern Italy, and for other areas of the Mediterranean. These datasets include both material culture (e.g. ceramic finds, marble, glass) and landscape data (e.g. relating to topography, rainfall, soil morphology). The first task will be to identify and extract relevant material relating to the western Mediterranean and to compile and clean the data in order to organise it in a form suitable for use and integration with the Italian datasets. This will also be the first step in making available a large integrated dataset for the western Mediterranean. The researcher will use these integrated datasets to undertake both macro- and micro-level analyses: at a macro-level, they will produce large-scale models of climate trends across the western Mediterranean for the first millennium CE to identify spatial and temporal variability; at a micro-level they will examine specific case-study areas in detail to identify patterns relating to relationships between humans and environmental variation. One casestudy area will be central and southern Italy; others will be identified in collaboration with other team members, depending on the quality and quantity of available evidence. Ideally this will include at least one area within the Iberian peninsula, and at least one within southern France. Information from textual sources (provided by Prof. Foxhall Forbes) will be integrated into these datasets and GIS-linked where possible. The researcher will undertake different kinds of analysis (e.g. principal component analysis) of various proxies to identify and investigate patterns of correlation and variation within the data, such as spatial and temporal variation in hydro-climate and its relationship with archaeological evidence.

## Who can apply

Prospective candidates are expected to hold a PhD in archaeology or related fields, in particular regarding aspects of environmental archaeology in the western Mediterranean and should have a suitable scientific / professional track record.

The candidate is invited to provide a list of his/her modern (and ancient, if relevant) language skills.

## Evaluation

Up to 100 points, specifically: For qualifications, publications and possible tests, from 0 to 60; For interview, from 0 to 40.

The following qualifications are considered as evaluation criteria:

a) a list of publications on research topics related to the subject of the project;

b) electronic submission of a maximum of 3 publications (in PDF format), already published or in press, which will be evaluated by the commission (one of which may be a chapter of the candidate's PhD thesis);

c) documented research activity following the PhD with contracts, research grants, short-term research fellowships, research fellowships and assignments;

e) attached 'preferential securities', if the candidate possesses them - see Article 5 of the competition available in Italian (<u>link</u>);

f) any other element provided for the announcement, to the articles 2, 3 and 5 of the competition available in Italian (link).

The interview aims to assess the candidates' skills and expertise on the following subjects:

- Knowledge of environmental archaeology in the western Mediterranean in the first millennium CE;
- Familiarity with relevant archaeological and environmental datasets;
- Knowledge of the English language.

At the end of his/her research activity, the research fellow is required to provide the Department with:

- The preparation of two scholarly articles on the subject;
- contribution to co-authored articles as part of the ERC project SSE1K;

- The preparation of a database of environmental and archaeological data.
