Research fellowship on "Water, Landscapes and Environmental History in the medieval Islamic Mediterranean, c. 600-c.1050 CE" - Università Ca' Foscari Venezia (Italian law 30 December 2010, n. 240, art. 22)

Description

The Department of Humanities at Ca' Foscari University of Venice (Dipartimento di Studi Umanistici dell'Università Ca' Foscari Venezia) invites applications for a fellowship in: "Water, Landscapes and Environmental History in the medieval Islamic Mediterranean, c. 600-c.1050 CE", Academic discipline: L-OR/10 – History of Islamic countries, duration 36 months, tutor prof. Helen Foxhall Forbes, financed by the ERC COG project "SSE1K - Science, Society and Environmental Change in the First Millennium CE", Grant Agreement n. 101044437, CUP: H73C22001720006, Principal Investigator Prof. Helen Foxhall Forbes.

Abstract: The post-doctoral researcher will examine the social and intellectual history of water in the Muslim-ruled territories around the Mediterranean from the seventh century to the early eleventh. They will carry out original research into Arabic geographical accounts and cartography alongisde archaeological evidence to analyse the toponymy of water resources and the practices and activities connected to these. They will analyse narrative and legal texts to identify specific rituals, practices and significant water-related events and conflicts. The researcher will work with Prof. Theresa Jäckh to make comparisons across different contexts and regions including the Islamic west. Excellent knowledge of Arabic is required and the knowledge of other languages relevant to this area such as Hebrew and Greek is particularly welcome. In addition to preparing their research for publication, the researcher will participate in the various activities of the SSE1K project, including attending team meetings and undertaking dissemination activities (conferences, seminars, workshops) on the project topics.

The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Ca' Foscari University of Venice.

This postdoctoral research position focuses on Islamicate culture in the Mediterranean to examine the social and intellectual history of water in North Africa, al-Andalus and Sicily from the seventh century to the early eleventh. It considers relationships between people and environments in different geographical regions where the religious and cultural contexts are similar. When the Muslims conquered North Africa, al-Andalus and Sicily, a key question for the evolving Islamic administration and law was how to distribute the territory's spoils and resources. Water not only played a key role as a vital source of life but also as a means to ensure religious purity (wudū'; tahāra). The role of water in Islamicate societies in North Africa, al-Andalus and Sicily has mainly been studied in relation to 1) the 'Green Revolution' that brought agricultural and economic innovation via water engineering and landscape architecture or 2) discourses within Islam relating to the symbolic and ritual meanings of water (Kabra 1997; Watson 2002; Quesada Morillas et al. 2016; Metcalfe 2017). WP4 takes a new approach: it investigates the social implications of water and how these related to changing environments in different regions in order to understand social interactions with, and attitudes to, water and related practices related on an intra- and inter-religious level. The postdoctoral researcher will work with Prof Theresa Jäckh (Eberhard Karls Universität Tübingen, Germany / Deutsches Historisches Institut Rom) to examine legal texts, narrative historical texts and scientific texts, and they will also integrate analysis of toponymy and excavated and published archaeological sites. They will contextualise their research with reference to published palaeoclimate and palaeoenvironmental studies, with support from Prof. Dominik Fleitmann (Universität Basel, Switzerland) and Prof. Dan Lawrence (Durham University, UK). In the multireligious societies in the Islamicate sphere water was a key element in defined in-group social conventions because of its specific spiritual and purifying importance: there are significant relationships to be examined in relation to gender and water, and the role that water played in the boundaries between some groups and those whom they considered 'unbelievers'. These issues must be examined in relation to the environmental and climatic fluctuation which affected the availability of water in different regions; comparison between regions will enable identification of specific responses to environmental variation across regions

Who can apply

Prospective candidates are expected to hold a PhD in historical studies or related fields, in particular regarding aspects of the history of the Islamic Mediterranean, its landscapes and environments and should have a suitable scientific / professional track record, in which an excellent working knowledge of Arabic must be declared.

The candidate is invited to provide a list of his/her modern and ancient language skills.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar. Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

Duration of contract: 36 months (approximately starting: 1st September 2023)

Stipend: The research fellowship amounts to 85.500,00 Euros, including taxes and social charges.

Deadline for submission of applications: 14th June 2023, h. 12.00 noon (Italian time).

Evaluation

Up to 100 points, specifically: For qualifications, publications and possible tests, from 0 to 60; For interview, from 0 to 40.

The following qualifications are considered as evaluation criteria:

- a) a list of publications on research topics related to the subject of the project;
- b) electronic submission of a maximum of 3 publications (in PDF format), already published or in press, which will be evaluated by the commission (one of which may be a chapter of the candidate's PhD thesis);
- c) documented research activity following the PhD with contracts, research grants, short-term research fellowships, research fellowships and assignments;
- e) attached 'preferential securities', if the candidate possesses them see Article 5 of the competition available in Italian (link);

f) any other element provided for the announcement, to the articles 2, 3 and 5 of the competition available in Italian (link).

The interview aims to assess the candidates' skills and expertise on the following subjects:

- Knowledge of the history of the Islamicate sphere and the medieval Mediterranean;
- Familiarity with relevant textual sources;
- Knowledge of the English language.

At the end of his/her research activity, the research fellow is required to provide the Department with:

- The preparation of three scholarly articles on the subject;
- contribution to co-authored articles as part of the ERC project SSE1K;
