**Research fellowship on relative to the scientific area of interest - Università Ca' Foscari Venezia  
(Italian law 30 December 2010, n.240, art. 22)**

**Description**

The Department of Management - Venice School of Management at Università Ca' Foscari Venezia invites application for n. 01 one-year post-doc fellowship in: **IUS/12 – Tax Law**.

The research may be carried out in Italian.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

**Who can apply**

Prospective candidates are expected to hold a **doctoral degree in Legal sciences, with research paper in Tax Law** and scientific-professional curriculum suitable to the development of research activities related to the fellowship.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar.

Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

**Duration of contract:** 12 months (approximately starting: September 2023).

**Stipend:** The research fellowship amounts to 19.367,00 Euros per year, including taxes and social charges depending on applicant' s filing statu(cost to Ca'Foscari : Euros 24.00,00.

**Research allowance:**

The successful candidate will have at his/her disposal a research allowance, equal to 968,35 Euros, aimed at covering actual research costs.

**Deadline for submission of applications: June 27<sup>th</sup>2023, 12.00 noon.**

**How to apply:**

Candidates shall submit:

1. The application form;

A motivation letter (max 1 page) along with their CV in European format, duly dated and signed, both to enclosed as a one single.pdf file ([link](#)); a declaration must be appended in the footnote of the curriculum, pursuant to the Italian DPR 445/2000 and subsequent amendments and additions, that the information provided corresponds to the truth. Moreover the candidates have to consent to the use of their personal data for the purposes of this selection procedure pursuant to the Italian Legislative Decree 196/2003 and to the EU Regulations 2016/679;
3. The attachments called “obligations and understanding” and “participation and compatibility”;

6. A copy of a valid identity document (either Identity Card or Passport);

#### Evaluation

The total mark of each candidate will be awarded based on 100 total points. The evaluation takes into account the criteria and thresholds described in the table below.
