#### **abstract:**

Silver economy, financial and pension literacy. The financial well-being of older individuals is affected by their ability to undertake informed decisions in terms of savings and investments along the whole life-cycle, in particular since their youth. This relationship is strengthened by the pension systems structure, which typically allow to complement public pensions with individual retirement accounts chosen by investors. The project will set-up an experimental framework aimed at quantifying the role of financial and pension literacy in the determination of the investment choices of young individuals.

**abstract:**

Silver economy, retirement and social networks. The project is aimed at empirically assessing how retirement affects the social networks and behaviour of older individuals in an ageing society. This analysis will shed light on the social connections of retirees, which is of key importance to design welfare state interventions as well as public and private services in order to foster the social inclusion of older individuals. The analysis will be based on longitudinal (possibly multicountry) microdata focusing on this specific population. Particular attention will be devoted to the architecture of the pension systems in the countries involved in the survey and to the mechanisms underlying the relation of interest, including the access to Information and Communication Technologies of older individuals and their proficiency in dealing with these tools.
