Description

The Department of Humanities at Ca' Foscari University of Venice (Dipartimento di Studi Umanistici dell'Università Ca' Foscari Venezia) invites applications for a fellowship in: "Political Discourse and Communal Living in Ancient Anatolia", Academic discipline: L-OR/04 Anatolian Studies, duration 36 months, tutor Dr. Annick Payne, financed by the ERC COG project "CAncAn - Communication in Ancient Anatolia", Grant Agreement n. 101088363, CUP: H73C23000170006, Principal Investigator Dr. Annick Payne.

Abstract: The researcher will work on text from Ancient Anatolia, specifically from and on the Lydians, Phrygians and Luwians; comparing internal and external perspective, to gain insight into the construction of identity. The scientific goal of studying political discourse and communal living is to gather new insight into identity formation. The researcher will analyze texts for political frameworks and interaction; adding them to a shared project database; visualizing findings on places of conflicts and representation of power on maps; relating results to religious and linguistic communities. The researcher will exchange with project colleagues, in particular on aspects of narrative bias and construction of narrative. This research will illuminate the construction of historical events, interaction and parameters and differences of political vs. other identities, making visible processes of identity formation. The research will be carried out in English.

The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Ca' Foscari University of Venice.

Who can apply

Prospective candidates are expected to hold a PhD in one of the following fields: Ancient History, Classics, Ancient Near Eastern languages, Comparative Philology, Linguistics and should have a suitable scientific / professional track record.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar. Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

Duration of contract: 36 months (approximately starting: 1st October 2023)

Stipend: The research fellowship amounts to 85,500 Euros, including taxes and social charges.

Evaluation

Up to 100 points, specifically: For qualifications, publications and possible tests, from 0 to 60; For interview, from 0 to 40.

The following qualifications are considered as evaluation criteria:

- a) list of publications on research topics related to the subject of the project;
- b) electronic submission of a minimum of 3 articles (in PDF) pertaining to any of the following relevant topics: Hittite, Luwian, Lydian, Phrygian material culture, history and languages; Anatolia in the 1st Millennium BC; History of Anatolian Studies; Indo-European linguistics;
- c) knowledge of Anatolian languages (attested through either courses taken or relevant publications);
- d) specialisation diplomas and attendance certificates at post-graduate specialization courses, obtained both

in Italy or abroad, documented research activity in public and private organisations with contracts, study grants or assignments both in Italy and abroad;

- e) attached 'preferential securities', if the candidate possesses them see Article 5 of the competition available in Italian (link);
- f) any other element provided for the announcement, to the articles 2, 3 and 5 of the competition available in Italian (link).

The interview aims to assess the candidates' skills and expertise on the following subjects:

- knowledge of Ancient Anatolian languages of the Bronze and Iron Ages
- familiarity with text corpora from and concerning Ancient Anatolia
- familiarity with Ancient Near Eastern political history
- knowledge of spoken English (interview to be held in English)

At the end of his/her research activity, the research fellow is required to provide the Department with:

- min. 2 papers accepted for publication per year, resulting from the work detailed below: Analysis of political framework and interaction; mapping of places of conflict and representation of power; relate findings to religious/linguistic entities; reconstruct historical events and interaction; compare parameters and differences of political and other identities; visualization of processes of identity formation;
- min. 1 contribution to co-authored articles resulting from project work per year.

The interview will be **on 26 September 2023**, **h. 2.00 p.m. (Italian time)** The interview will be held in remote with Google Meet.
