Research fellowship on "Imperial Entanglements: the politics of comparison in Japan's colonial policy"

Description

The Department of Asian and North African Studies at Università Ca' Foscari Venezia invites applications for a fellowship in:

Title: "Imperial Entanglements: the politics of comparison in Japan's colonial policy"

Scientific sector: L-OR/23

Scientific supervisor and tutor: Prof. Andrea Revelant

Duration: 12 months, renewable

Abstract:

The project is part of the PRIN project "Imperial Entanglements: Latecomer Colonial Empires and the "Politics of Comparison" (1880s-1940s)", conducted jointly by the Department of Asian and North African Studies (DSAAM) and the research units at the University of Naples and the University of Eastern Piedmont. For the overall objectives of the PRIN, please refer to the description below. The person selected for this contract will join the DSAAM research unit, working on the case of imperial Japan. They will carry out full-time research activities, according to the work plan agreed with the head of the local unit. They will have no obligation to reside in Italy during the contract term. The selection interview will be held in English.

"Imperial Entanglements" investigates four cases of latecomer imperialism, namely those of Germany, Italy, Belgium and Japan. Each of these countries entered the phase of colonial expansion only in the late nineteenth century. Because of this delayed inception, when their power elites and experts shaped new structures of imperial rule they had to consider existing models of imperial rule and colonial administration, as previously established by other powers. In pursuit of original visions of their imperial project, they critically engaged with the existing models, adopting, refashioning, or rejecting their constituent features. As colonial powers, Japan, Italy, Germany occupied a relatively marginal position within the international system. Germany even lost its empire owing to defeat in the Great War. Dissatisfied with their standing in the world, in the 1930s the three countries launched a frontal challenge to the international order by portraying their imperial model as an alternative to previous imperialism.

Our study of the circulation and re-elaboration of political models spans from the 1880s to the 1940s, encompassing both the so-called Age of Empires and the post-Wilsonian moment, when colonialism was deeply refashioned across the world owing to the emergence of strong anti-colonial movements. The research is pivoted on two mainstays. The first is what Ann L. Stoler has termed the "politics of comparison," that is the way in which contemporary actors compared their own colonial rule with others. This concept highlights the importance of knowledge transfers as a constituent part of empire building, while also drawing attention to the "politics" of distancing oneself from the other. The second is the focus on transimperial actors, be they intellectuals, politicians or institutions [Stoler 2001; Heé, Hedinger 2018].

The project is based upon and wants to further develop the analytical category of the latecomer colonial empires as a peculiar category of empire formation. We consider it key to promoting a deeper understanding of imperialism as a global phenomenon. The research will be centered on the following questions:

- How did politicians and intellectual elites represent their empires and colonial policies in relation to other empires?

- To what extent, when, and how did they try to establish transimperial bonds?



- What kind of transimperial networks did their elites strive to build in their pursuit to elaborate their own model of colonial policy?

- Is it possible to identify major shifts in the "politics of comparison" and the transimperial bonds established in the considered period?

- How did the international circulation of models affect jurists and rulers in latecomer empires and their perception of the colonial rule?

Who can apply

Candidates must hold a doctoral degree and have a CV suitable for the requested research activities.

The interview will focus on the following criteria:

- Methodological skills, applicable to the specific topics of the research project, planning of activities and discussion of research perspectives relating to the project
- Assessment of knowledge of English and Japanese language proficiency

Ca' Foscari encourages applications from researchers who have received positive evaluation in all the criteria applicable to funding programs, such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar. Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

Duration of contract: 12 months (approx. start: November, 01st, 2023).

Stipend: The research fellowship amounts to 19,367 Euros per year, including taxes and social charges.

A share of the project funds will be available for the reimbursement of research expenses.

Deadline for submission of applications: October 4th, 2023, 12.00 noon.

How to apply:

Evaluation

Up to 100 points, specifically: For CV and publications, from 0 to 60; For interview, from 0 to 40.

Selection procedure

Short-listed candidates will be invited for interview on **October, 23rd, 2023 at 10.00 AM** at Department of Asian and North-African Studies, Palazzo Vendramin dei Carmini, Dorsoduro 3462, 30123 Venezia.

The interview can also be held via Zoom video conference, following a reasoned request by the candidate.
