Research fellowship on "#EtiamEgo. Description

The Department of Humanities at Ca' Foscari University of Venice (Dipartimento di Studi Umanistici dell'Università Ca' Foscari Venezia) invites applications for a fellowship in: "#EtiamEgo. Violence against women in ancient Rome (Archaic and Late-Republican Age): comprehensive analysis of the case studies; data processing into the digital platform.", Academic discipline: L-ANT/03 Roman history, duration 12 months, tutor Prof. Francesca ROHR, financed by the PRIN 2022 project "#EtiamEgo. Violence against women in ancient Rome: historical perspectives and symbolic constructions." (codice progetto 2022PC8Y93), CUP: H53D23000290006 Head of Unit, Prof. Francesca ROHR.

Abstract: This research aims to investigate models, behaviors and features of violence against women (women coming from élite families - senatorial and Equestrian - and those belonging to the lower classes) in Ancient Rome (Late-Republican Period and Archaic Age) through an analysis of the ancient sources. The research assistants will be expected to conduct a census and systematic examination of literary, historiographic, epigraphic, legal and numismatic through paper and digital archives, using keywords, to identify case studies and classify them, by an open access digital platform, based on indicators related to the historical reconstruction - protagonists, different forms of violence, motivations behind the violent action - and to the historiographical representation of the phenomenon - narrative format, lexicon/vocabulary.

The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Ca' Foscari University of Venice.

Who can apply

Prospective candidates are expected to hold a PhD in Ancient Heritage Studies and an appropriate scientific-professional curriculum.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar. Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

Duration of contract: 12 months (approximate starting date: 1st November 2023)

Stipend: The research fellowship amounts to 19,367 Euros, including taxes and social charges.

Deadline for submission of applications: 10th October 2023, h. 12.00 noon (Italian time).

enclosed as a one single.pdf file (<u>link</u>); a declaration must be appended in the footnote of the curriculum, pursuant to the Italian DPR 445/2000 and subsequent amendments and additions, that the information provided corresponds to the truth. Moreover the candidates have to consent to the use of their personal data for the purposes of this selection procedure pursuant to the Italian Legislative Decree 196/2003 and to the EU Regulations 2016/679;

- 4. All documents, qualifications and publications relevant for the selection procedure (please, see the notice link);

Evaluation

Up to 100 points, specifically: For qualifications, publications and possible tests, from 0 to 60; For interview, from 0 to 40.

The following qualifications are considered as evaluation criteria:

- a) list of publications on research topics related to the subject of the project;
- b) specialization diplomas and attendance certificates at post-graduate specialization courses, obtained both in Italy or abroad, documented research activity in public and private organizations with contracts, study grants or assignments both in Italy and abroad;
- c) attached 'preferential securities', if the candidate possesses them see Article 5 of the competition available in Italian (link);

d) any other element provided for the announcement, to the articles 2, 3 and 5 of the competition available in Italian (link).

The interview aims to assess the candidates' skills and expertise on the following subjects:

- Knowledge about Family and Women's History in the Roman World, proven by the organization of conferences, meetings and seminars at Italian and foreign Institutions, scientific publications and scientific research on the topic;
- Proficiency in managing pages in websites;
- Knowledge of the English language.

At the end of his/her research activity, the research fellow is required to provide the Department with:

- Comprehensive analysis of the case studies; data processing into the digital platform.
