Research fellowship on "Fostering sustainability mindset: how non-financial disclosure and corporate risk assessment may drive ESG value creation" - Università Ca' Foscari Venezia (Italian law 30 December 2010, n. 240, art. 22 and subsequent amendments and additions).

Description

The Department of Management at Università Ca' Foscari Venezia invites application for one-year fellowship in Fostering sustainability mindset: how non-financial disclosure and corporate risk assessment may drive ESG value creation, under the supervision of prof. Chiara Mio (SSD SECS-P/07 - Business Administration and Accounting Studies).

Project acronym: PRIN 2022 "Fostering sustainability mindset: How non-financial disclosure and corporate risk assessment may drive ESG value creation" n. 2022CTBNRN – CUP H53D23002380006

Abstract: The project aims to enhance companies' ability in the European Union (EU) to improve their performance along with environmental, social and governance (ESG) dimensions and mitigate the associated risks and to develop models and instruments for increasing corporate accountability. The project's theoretical and practical relevance can be related to two initiatives undertaken at the EU level. The first is the Next Generation EU (NGEU) recovery fund, initiated in 2020 to mitigate the COVID-19 pandemic impact, which authorizes the European Commission to borrow funds on the capital markets to address economic and social damages. Second, on 5 January 2023 the Corporate Sustainability Reporting Directive (CSRD) entered into force. It amends and extends the sustainability reporting requirements introduced by the EU Directive 2014/95/EU (EUD). In the light of these initiatives, there is a need for scholars and practitioners to develop a better understanding of the mechanisms effectively implementable at the EU level to induce responsible corporate behaviour and stimulate long-term value creation. The project examines effects of CSRD on the evolution of risk representation in corporate reporting and explores disclosure content on risks, develops risk taxonomy and analyzes it from an evolutionary perspective.

The research may be carried out in Italian end English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

Who can apply

Prospective candidates are expected to hold a master's degree in Economics, Management area and scientific-professional curriculum suitable to the development of research activities related to the fellowship.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar.

Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

Duration of contract: 12 months (approximately starting: November 2023), with the possibility of renewal within the limits of art. 2 of the Regulations on university research fellowship awarding, which will be subject to a specific contract.

Stipend: The research fellowship amounts to **19.456,00** *Euros* **per year**, including taxes and social charges depending on applicant's filing status (cost to Ca' Foscari € 24.000,00).

Deadline for submission of applications: October 17th 2023, 12 noon (Italian time).



How to apply:

Candidates shall submit:

- 1. The application form;
- 2. A motivation letter (max 1 page) along with their CV in European format, duly dated and signed, both to enclosed as a one single.pdf file (<u>link</u>); a declaration must be appended in the footnote of the curriculum, pursuant to the Italian DPR 445/2000 and subsequent amendments and additions, that the information provided corresponds to the truth. Moreover the candidates have to consent to the use of their personal data for the purposes of this selection procedure pursuant to the Italian Legislative Decree 196/2003 and to the EU Regulations 2016/679;
- 3. The attachments called "obligations and understanding" and "participation and compatibility";
- 4. All documents, qualifications and publications relevant for the selection procedure (please, see the notice link);
- 5. A copy of a valid identity document (either Identity Card or Passport);
- 6. (If available) Evaluation Summary Reports of Marie Skłodowska Curie Actions Individual Fellowships/ ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) individual proposals having passed all the evaluation thresholds;
