Research fellowship on "Comparative statics under limited attention" - Università Ca' Foscari Venezia (Italian law 30 December 2010, n. 240, art. 22 and subsequent amendments and additions).

## Description

The Department of Management at Università Ca' Foscari Venezia invites application for one 15-month fellowship in **Comparative statics under limited attention**, under the supervision of prof. Marco Li Calzi (SSD SECS-S/06 - Mathematical methods of economics, finance and actuarial sciences).

# Project acronym: PRIN 2022 "Nudging under Limited Attention" n. 20222Z3CR7 – CUP H53D23002130006.

**Abstract**: This project is part of a larger effort to develop a methodology for the evaluation of nudges, geared to agents who make rational choices but are constrained by limited attention. Specifically, the main objective is to derive sufficient conditions under which a frame is revealed to induce more attentiveness.

The research may be carried out in Italian end English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

#### Who can apply

Prospective candidates are expected to hold a master's degree in Economics, Mathematics, Statistics, Computer Science, Physics or equivalent degrees and scientific-professional curriculum suitable to the development of research activities related to the fellowship.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar.

Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

**Duration of contract:** 15 months (approximately starting: January 2024), with the possibility of renewal within the limits of art. 2 of the Regulations on university research fellowship awarding, which will be subject to a specific contract.

The departments, including the central administration, may finance research fellowships with department funds, as well as with funds from national or European projects, agreements, research contracts, third party contracts, donations, or any other source of external funding.

**Stipend**: The research fellowship amounts to **30.204,00** *Euros*, including taxes and social charges depending on applicant's filing status (cost to Ca' Foscari € 37.257,64).

Candidates shall submit:

Moreover the candidates have to consent to the use of their personal data for the purposes of this selection procedure pursuant to the Italian Legislative Decree 196/2003 and to the



EU Regulations 2016/679;

Evaluation

The evaluation takes into account the criteria and thresholds described in the table below.
