Research fellowship on "Mapping internationalization trajectories of Italian firms towards Central, Eastern Europe and Russia from the 1970s to 2000" - Università Ca' Foscari Venezia (Italian law 30 December 2010, n. 240, art. 22 and subsequent amendments and additions).

Description

The Department of Management at Università Ca' Foscari Venezia invites application for one-year fellowship in Mapping internationalization trajectories of Italian firms towards Central, Eastern Europe and Russia from the 1970s to 2000, under the supervision of prof. Valentina Fava (SSD SECS-P/12 – Economic History).

Project acronym: PRIN 2022 "Reframing Globalization in European Peripheries: Intellectual and Expert Networks Facing Political and Economic Transformations (1975-2022) n. 2022RYN7BX - CUP H53D23000300001.

Abstract: The research aims at mapping the presence of Italian firms in CEE from the 1970s to early 2000s according to sector and type of investment. Since the 1970s, corporate-related research centers and think tanks monitored political and economic changes taking place in CEE searching for new market opportunities for Italian goods as well as new forms of industrial cooperation\integration. Economic actors' technical observations rested on specific but well-informed visions of the evolution of the role of the state, management and market in Central Eastern European countries. We will study how, in this evolving context, Italian businesses figured out their business opportunities in Eastern Europe in relation to both political and economic changes in the area. The aim is to reconstruct how the business analysts' suggestions changed overtime, which factors they did consider as critical in the choice of investment location as well as investment form. Research will also focus on how Italian business and economic experts interpreted the changing attitudes of Eastern European managerial and political elites towards market, FDIs and privatization. Research work will be based on archival sources and semi-structured interviews.

The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

Who can apply

Prospective candidates are expected to hold a master's degree in historical-humanities or economic area and scientific-professional curriculum suitable to the development of research activities related to the fellowship.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar. Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

Duration of contract: 12 months (approximately starting: December 2023), with the possibility of renewal within the limits of art. 2 of the Regulations on university research fellowship awarding, which will be subject to a specific contract.

Stipend: The research fellowship amounts to **19.456,00** *Euros* **per year**, including taxes and social charges depending on applicant's filing status (cost to Ca' Foscari € 24.000,00).

Deadline for submission of applications: November 27th 2023, 12 noon (Italian time).

How to apply:



Candidates shall submit:

- 1. The application form;

A motivation letter (max 1 page) along with their CV in European format, duly dated and signed, both to enclosed as a one single.pdf file (link); a declaration must be appended in the footnote of the curriculum, pursuant to the Italian DPR 445/2000 and subsequent amendments and additions, that the information provided corresponds to the truth. Moreover the candidates have to consent to the use of their personal data for the purposes of this selection procedure pursuant to the Italian Legislative Decree 196/2003 and to the EU Regulations 2016/679;
