Description

The Department of Philosophy and Cultural Heritage at Università Ca' Foscari Venezia invites applications for a fellowship financed by the Project "ROSMINI - Analysis and Resources of Rosmini's Thought in a Digital Environment", CUP: H53D23009330001, Programme PRIN 2022 PNRR, manager of the project for the Department of Philosophy and Cultural Heritage prof. Duration: 12 months

Abstract: The project ROSMINI - Analysis and Resources of Rosmini's Thought in a Digital Environment aims to develop a digital platform that allows different ways of textual research together with the philosophical investigation of the most relevant works (in 19th century edition) of Antonio Rosmini (1797-1855). The project intends to make use of the innovations allowed by the field of Digital Humanities, together with philosophical reflection on the content of Rosmini's works and its intellectual richness. The assignee will have to collaborate in the digitisation and editing of the introductions, notes and tags that will accompany the digitised works of Rosmini. The assignee will also be involved in the dissemination of the results of the project (meetings in high schools, libraries and cultural centres of national importance). The research fellow will assist the PI in the various activities foreseen, in the organisation of the final conference of the project and in the publication of the proceedings. During the fellowship period, the research fellow will also have to produce two scientific articles dedicated to the philosophical themes of the project.

The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

Who can apply

Prospective candidates are expected to hold a PhD in Philosophy, or related disciplines.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar.

Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.









Duration of contract: 12 months (approximately starting: **January 1st, 2024**)

Stipend: The research fellowship amounts to 22.700,00 Euros per year, including taxes and social charges.

Deadline for submission of applications: November 14th, 2023, at noon (Italian time).

How to apply:

Candidates should submit:

- 1. The application form;
- 2. A motivation letter (max 1 page) along with their CV in European format, duly dated and signed, both to enclosed as a one single.pdf file. (link)
- 3. A copy of a valid identity document (either Identity Card or Passport);
- 4. The attachments called "obligations and understanding" and "participation and compatibility";
- 5. the possession of a PhD, with the date on which it was obtained and the University where the course was held. Candidates must also submit a copy of the foreign title with a translation in Italian or English language including marks obtained, accompanied by a self-declaration relating to the conformity to the original of the translation itself;
- (If available) Evaluation Summary Reports of Marie Skłodowska Curie Actions Individual Fellowships/ ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) individual proposals having passed all the evaluation thresholds;
- 7. (If available) Details of Marie Skłodowska Curie Actions Individual Fellowships, ERC Starting Grants, FIRB (Italian Fund for basic research investments)/ SIR Scientific Young Independence Research funded projects;

- 9. A copy, in PDF format, of maximum of no. 5 scientific publications, attached to the application form;
- 10.All documents, qualifications and publications relevant for the selection procedure (please, see the notice link).

The candidate, after the uploading, will receive a submission number and an e-mail acknowledging receipt of his/her application.

The candidate if necessary could access the procedures for updating any data and materials by the link provided by the e-mail, in any case any updates must be made no later than the deadline, **November 14th**, **2023**, at noon (Italian time).

Please note that the University can be contacted for any support needed by the candidate until 24 hours prior to the deadline.

Please note that in case of an high number of applications and / or weight of the materials loaded by the candidates the system might become slower, Therefore it is suggested not to start the process close to the deadline.

Evaluation

Up to 100 points, specifically: For qualifications, publications and possible tests, from 0 to 60; For the interview, from 0 to 40.

Selection procedure

Short-listed candidates will be invited for interview on **December 4**th, **2023**, at **11:00** a.m. (Italian time) via **Google Meet**.

The short-list of the candidates admitted to the interview and the related calendar, or any postponement, will be published on the University's webpage on **November 27**th, **2023** (link).
