#### Description

The “Centro Temporaneo Progetto CHANGES” at Università Ca' Foscari Venezia invites applications for a fellowship in:

**Title:** “Disseminating the Antiquity: Realisation of Multimedia Supports for the valorisation of Epigraphic Collections held at the Archaeological Museums of the Venetian lagoon and coastline”

**SSD or Research sector:**L-ANT/03 (Storia romana)

**Scientific coordinator or supervisor:** Prof.ssa Francesca Rohr

**Duration:** 12 months

**Abstract:** Knowledge of the ancient landscape of an area also passes through the study of epigraphic evidence displayed in archaeological museums. The project aims at the realisation of multimedia supports for the valorisation of the epigraphic collections held at the Archaeological Museums of the Venetian lagoon and coastline and for their virtual tour, in preparation for the on-site one. The project is born from the idea that an effective fruition of the tour at the museum, which is organised for a diversified audience composed of researchers, but also of students, enthusiasts and tourists with different backgrounds and education, benefits from multimedia devices providing explanatory introductions to visitors. The researcher's activity should follow two lines of action. As a necessary premise, the researcher will have to study the epigraphic finds in the Museum, paying particular attention to those most significant for the historical study of the lagoon in Roman time. Subsequently, for each artefact selected, the researcher will have to produce in-depth texts on two levels: a first level for the specific explanation of the epigraphic artefact; a second level for the explanation of more general aspects of the social, economic, cultural and religious history of the Roman civilisation that the artefact testifies to. The texts will be converted in podcasts and will be accessible, so that the visitor will have to choose the level of depth. The researcher will also have to prepare the texts for the virtual tour of the museum collections. The project is therefore a research initiative aimed at the final realisation of a product in the field of public engagement.

The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

#### Who can apply

Prospective candidates are expected to hold a **PhD in Classics and Ancient History** and appropriate scientific-professional curriculum.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar.

Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

The following are considered preferential qualifications:

- A suitable CV fitting the scientific requirements of the project;
- Specialisation diplomas and attendance certificates at post-graduate specialisation courses, obtained

both in Italy and abroad, the performance of documented research activity in public and private organisations with post-doctoral fellowships, contracts, study grants or assignments both in Italy and abroad;

**Duration of contract:** 12 months (approximately starting in february 2024)

**Stipend:** The research fellowship amounts to 19.367,00 Euros gross percipient, net of charges to be borne by the institution.

**Deadline for submission of applications: December 13<sup>th</sup>, 2023 noon CET**

#### How to apply:

Candidates shall submit:

1. The application form;
2. A motivation letter (max 1 page) along with their CV in European format, duly dated and signed, both to enclosed as a one single.pdf file ([link](#)); a declaration must be appended in the footnote of the curriculum, pursuant to the Italian DPR 445/2000 and subsequent amendments and additions, that the information provided corresponds to the truth. Moreover, the candidates have to consent to the use of their personal data for the purposes of this selection procedure pursuant to the Italian Legislative Decree 196/2003 and to the EU Regulations 2016/679;
3. The attachments called "obligations and understanding" and "participation and compatibility";
4. All documents, qualifications and publications relevant for the selection procedure (please, see the notice - [link](#));
5. A copy of a valid identity document (either Identity Card or Passport);

### **Evaluation**

Up to 100 points, specifically:

For qualifications, publications and possible tests, from 0 to 60;

For interview, from 0 to 40.

### **Selection procedure**

The interview will be on **December 22<sup>th</sup>, 2023 at 09.00 a.m. (Italian time)** in presence at **Palazzo Marcorà Malcanton, 1° Piano Studio 1A07, Dorsoduro 3484/d - Venezia (VE)**.

The short-list of the candidates admitted to the interview, or any postponement, will be published on the University's webpage on **December 15<sup>th</sup>, 2023** ([link](#)).

**It is the candidate's responsibility to check the admission results and, if admitted, to show up at the required date and time.**

The interview may ascertain knowledge of the following topic:

- The history of the Eastern Veneto Museums and the musealization of the epigraphic finds;
- The history of the Venetia in Roman Age;
- Thorough knowledge of the main epigraphic databases belonging to the EAGLE network (Europeana network of Ancient Greek and Latin Epigraphy), with particular reference to EDR (Epigraphic Database Roma);
- Public history techniques for communicating Roman history and epigraphic heritage to a non-academic audience;
- Fluency in English.
