







Research fellowship on "Archaeology of agropastoral landscapes in the Kurdish-iraqi piedmont" – Department of Humanities Ca' Foscari University of Venice

Description

The Department of Humanities at Ca' Foscari University of Venice invites applications for a fellowship in: "Archaeology of agropastoral landscapes in the Kurdish-iraqi piedmont", Academic discipline: L-OR/11 Muslim archaeology and art history, duration 22 months, tutor Prof. Cristina TONGHINI, financed by the PRIN 2022 PNRR project "P2022MBJ3C - Community Archaeology of Endangered Agropastoral Landscapes of Upper Mesopotamia (CArE)", CUP: H53D23010260001, Principal Investigator Prof. Cristina TONGHINI.

Abstract

This research is part of the Prin 2022PNRR project CArE, a multidisciplinary programme that combines archaeological practice with anthropological, ethnographic, and human geography approaches to investigate the unexplored, highly threatened, and unprotected archaeological landscape of the piedmont of the Kurdistan Autonomous Region (Iraq); it aims to contribute to the process of identity reconstruction for the communities that inhabit this territory today. More specifically, the research looks at the agropastoral archaeological landscape of a wide foothill belt extending between the modern villages of Faida and Ba'adre to be investigated using experimental procedures and advanced techniques.

The researcher's activities will involve:

- Desk-based detection and recording of the archaeological evidence (remote sensing);
- Field-based detection and recording of the archaeological evidence: intensive field survey, UAV photogrammetry, excavations of selected sample sites;
- Data processing, creation of a GIS (ArcGIS), Bayesan models, thematic maps, orthophotos,topographic maps and 3D models of the various sites and features using specific software (e.g. Metashape);
- Data analysis and interpretation.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Ca' Foscari University of Venice.

Prospective candidates are expected to hold a PhD (archaeology) and a suitable scientific / professional track record.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar. Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar. Duration of contract: 22 months (approximate starting date: 1st February 2024)

Stipend: The research fellowship amounts to 42,500 Euros, including taxes and social charges.

Deadline for submission of applications: 18th December 2023, h. 12.00 noon (Italian time).

The candidate, after the uploading, will receive a submission number and an e-mail acknowledging receipt of his/her application.

Evaluation

Up to 100 points, specifically: For qualifications, publications and possible tests, from 0 to 60; For interview, from 0 to 40.

The following qualifications are considered as evaluation criteria:

- a) list of publications;
- b) specialization diplomas and attendance certificates at post-graduate specialization courses, obtained both in Italy or abroad, documented research activity in public and private organizations with contracts, study grants or assignments both in Italy and abroad;









- c) certificates and other qualifications specifically relevant to the research activity to be carried out; more specifically this call requires: solid (stratigraphic) excavation experience, especially in extra-European and middle-eastern contexts, and with supervisory responsibility; GIS skills, data-base, statistics, Bayesan models, topographic surveying and 3D modelling in archaeology; research experience on mobile communities; research experience in Islamic archaeology, especially in relation to rural communities.
- d) attached 'preferential securities', if the candidate possesses them see Article 5 of the competition available in Italian (link);
- e) any other element provided for the announcement, to the articles 2, 3 and 5 of the competition available in Italian (link).

The interview aims to assess the candidates' skills and expertise on the following subjects:

- GIS, data-base, and statistical skills in archaeology; Bayesan models;
- skills in archaeological and topographical survey, 3D modelling in archaeology;
- skills in the study of mobile communities and communities in the rural Islamic world;
- knowledge of English language.

At the end of his/her research activity, the research fellow is required to provide the Department with:

• A GIS with thematic maps, orthophotos, floor plans, topographic maps and 3D models of the identified sites.

Selection procedure

The interview will be on 16th January 2024, h. 9:00 a.m. The interview will be held in remote with Google Meet.
