Research fellowship on "For a Multivocal History of the Attitudes Towards Non-human Animals in South Asia. Ethics, Practices, Symbolism. Investigating New and Unsolved Issues" - Università Ca' Foscari Venezia

(Italian law 30 December 2010, n.240, art. 22 and subsequent amendments and additions)

#### Description

The Department of Asian and North African Studies at Università Ca' Foscari Venezia invites applications for a fellowship in:

- **Title:** For a Multivocal History of the Attitudes Towards Non-human Animals in South Asia. Ethics, Practices, Symbolism. Investigating New and Unsolved Issues

- Abstract:

The project is focussed on the interface between human and animal and must concern itself with at least one of the six study subjects:

## 1) ANALYSING CLASSIFICATIONS, CONTINUITY AND MIRRORINGS.

Starting with the ancient classifications of living beings found in Brahmanical literature, this area investigates the social stratification, control and hierarchical differences present among both animals and humans. It also explores the phenomenon of imitation of animal behaviour in yogic and ascetic traditions, emphasising an attempt at reintegration into a larger, more fluid set of living beings.

## 2) DETERMINING THE MEANINGS OF THE DIVINE ANIMAL.

The theriomorphic and therioanthropic concept of deities is analysed to understand their morphologies, classifications in texts and specific symbolism. The attribution of 'vehicles' to deities and their relationships is also addressed, exploring contrasting and harmonious connections on various planes.

# 3) REDEFINING THE GENESIS AND INTERRELATIONS OF NONVIOLENCE AND VEGETARIANISM.

This area focuses on the origins and evolution of concepts such as ahimsā (nonviolence) and vegetarianism, analysing their interconnections with Vedic religiosity and interpretations in different traditions such as Buddhism, Jainism and Brahmanism. Such an investigation also offers insights to contribute to contemporary discourse on vegetarianism.

## 4) INVESTIGATING THE OUTCOMES OF INDO-MUSLIM INTERACTION.

It explores how Indian Islam conceived of the human-animal relationship, focusing on the theory of Muslim or infidel animals and the works of Indo-Persian authors who dealt with zooanthropological phenomenology.

## 5) COLONIAL DISCOURSE AND THE NARRATIVE LEGACY.

Through an examination of English legislation in India on animal protection and representations of human and non-human colonisers in imperial literature and positions on public health, ethics and nutrition, define the role of these representations in the construction of colonial rule and in contemporary Indian narratives.

## 6) CASE STUDIES ON CONTEMPORANEITY.

The facets of vegetarianism in today's India are examined, reflecting on its social, cultural and political impact.

Another study deals with the interactions between some indigenous communities in north-east India and their view of the interaction between humans and animals, also offering an environmental analysis perspective.









This project promises to shed new light on the complex relationship between humans and animals in historical and contemporary India, highlighting the multiple cultural, religious and social facets that define its nature and complexity.

A knowledge of Italian language, both written and oral, of level C2 and of English language, both written and oral, of level B2 is required for the assignment.

The project is part of the PRIN project "For a Multivocal History of the Attitudes Towards Non-human Animals in South Asia. Ethics, Practices, Symbolism. Investigating New and Unsolved Issues" conducted jointly by the Department of Asian and North African Studies (DSAAM) and the research units at University of Milan, University of Turin and University of Bologna

The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

## Who can apply

Prospective candidates are expected to hold a master's degree and have a CV suitable for the requested research activities

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar. ## Evaluation

Up to 100 points, specifically: For qualifications, publications and possible tests, from 0 to 60; For interview, from 0 to 40.
