### **Description**

The Department of Humanities at Ca' Foscari University of Venice (Dipartimento di Studi Umanistici dell'Università Ca' Foscari Venezia) invites applications for a fellowship in: "Women's history in transnational perspective with a specific focus on archival collections in the United States", Academic discipline: M-STO/04 Contemporary History, duration 24 months, tutor Dr. Chiara Bonfiglioli, financed by the ERC COG project "WO-NAM - Women and Non-Alignment in the Cold War era: biographical and intersectional perspectives", Grant Agreement n. 101088489, CUP: H73C23000940006, Principal Investigator Dr. Chiara Bonfiglioli.

**Abstract:** The fellowship focuses on women's history in transnational perspective with a specific focus on archival collections in the United States. The fellowship will be developed within the framework of the WO-NAM project, funded by an ERC Consolidator Grant and led by PI Prof. Chiara Bonfiglioli. WO-NAM addresses the history of women's participation in the Non-Aligned Movement during the Cold War era, studying the roles of female leaders, women's movements and women's organizations. Bringing together women's and gender history, global history, and intellectual history, WO-NAM will draw on rich and diverse archival collections on women's activism in its focus on the case studies of Yugoslavia, Egypt, Tunisia, India, and Cuba, as well as on video interviews with some of the protagonists of these events. The project also includes a survey of existing archival collections in the United States, related to the history of women's internationalism during the Cold War.

The fellow will work closely with the PI, Prof. Chiara Bonfiglioli, primarily to conduct archival research in the United States, in a variety of archives including the Sophia Smith collections and the Schlesinger Library, to reconstruct transnational connections between activists during the Cold War. The fellow will also contribute to the project website, database and social media, and to the overall development of the project.

The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Ca' Foscari University of Venice.

#### Who can apply

Prospective candidates are expected to hold a PhD in Contemporary History and should have a suitable scientific / professional track record.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar. Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

**Duration of contract:** 24 months (approximately starting: 1st March 2024)

Stipend: The research fellowship amounts to 54.300 Euros, including taxes and social charges.

Deadline for submission of applications: 9th January 2024, h. 12.00 noon (Italian time).

# How to apply:

Candidates shall submit:

- 1. The application form;
- A motivation letter along with their CV in European format, duly dated and signed, both to enclosed as a
  one single.pdf file (<u>link</u>); a declaration must be appended in the footnote of the curriculum, pursuant to
  the Italian DPR 445/2000 and subsequent amendments and additions, that the information provided
  corresponds to the truth. Moreover the candidates have to consent to the use of their personal data for
  the purposes of this selection procedure pursuant to the Italian Legislative Decree 196/2003 and to the
  EU Regulations 2016/679;
- 2. The attachments called "obligations and understanding" and "participation and compatibility";
- 3. All documents, qualifications and publications relevant for the selection procedure (please, see the notice link);
- 4. A copy of a valid identity document (either Identity Card or Passport);
- 5. (If available) Evaluation Summary Reports of Marie Skłodowska Curie Actions Individual Fellowships/ ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) individual proposals having passed all the evaluation thresholds;

#### **Evaluation**

Up to 100 points, specifically: For qualifications, publications and possible tests, from 0 to 60; For interview, from 0 to 40.

The following qualifications are considered as evaluation criteria:

- a) list of publications on research topics related to the subject of the project;
- b) Proven research experience in United States archives;
- c) Specialization diplomas and certificates of attendance of post-graduate specialization courses, obtained both in Italy and abroad, carrying out of documented research activities at public and private entities with contracts, research grants, scholarships or assignments both in Italy and abroad;
- d) attached 'preferential securities', if the candidate possesses them see Article 5 of the competition available in Italian (link);
- e) any other element provided for the announcement, to the articles 2, 3 and 5 of the competition available in Italian (link).

The interview aims to assess the candidates' skills and expertise on the following subjects:

- · Research knowledge of women's and gender history;
- Research knowledge of Cold War history;
- Knowledge of English, with specific reference to the themes of the call.

At the end of his/her research activity, the research fellow is required to provide the Department with:

- One multi-author peer-reviewed publication together with the PI;
- One peer reviewed publication;
- Two presentations at international conferences;
- Insertion of 5 entries in the WO-NAM database.
