Description

The Department of Humanities at Ca' Foscari University of Venice (Dipartimento di Studi Umanistici dell'Università Ca' Foscari Venezia) invites applications for a fellowship in: **“Human-cattle relations in Colombia and Argentina through an inter-disciplinary perspective which takes into consideration disciplines such as ethology, zoology, animal behaviour and welfare”**, Academic discipline: BIO/05 – Zoology and AGR/19 – Special Zootechnics, duration 12 months, tutor Dr. Valentina Bonifacio, financed by the ERC COG project “CowDom - Between domestication and ferality: cattle-human relationships in the making of post-colonial South-American society”, Grant Agreement n. 101088949, CUP: H73C23000470006, Principal Investigator Dr. Valentina Bonifacio.

Abstract: The ERC project Cow-Dom aims at understanding how different configurations of human-cattle relations reflect social, economic and political dynamics in four countries in post-colonial South America. It will answer this question by analyzing the values, practices and colonial legacies related to human-cattle relationships in four South American countries - Brasil, Argentina, Paraguay and Colombia - by focusing on the opposite poles of the domestication process: genetically improved races and feral or semi-feral creole cattle. Through long-term ethnographic fieldwork, interdisciplinary teams of zoologists and anthropologists will observe and analyse cattle-human relational behaviours in cattle fairs and historical feral cattle territories. The zoologist (or trained in related disciplines) will work in close collaboration with an anthropologist, with whom s/he will carry out long term fieldwork periods in Argentina and Colombia. More broadly, s/he will be part of a team of six people who will work in close coordination with each other, and will meet them regularly every six months in South America or Venice. The researcher is also requested to spend an initial period of time (about 1 month) in Venice, before the beginning of the fieldwork.

The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Ca' Foscari University of Venice.

Who can apply

Prospective candidates are expected to hold **a PhD in one of the following fields: Animal Biology, Zoology, Zootechnics, Ethology, Applied Ethology, Animal behaviour and welfare, and should have a suitable scientific / professional curriculum.**

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar. Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

Duration of contract: 12 months (approximately starting: 1st May 2024)

Stipend: The research fellowship amounts to **27,000 Euros**, including taxes and social charges.



Deadline for submission of applications: 29th February 2024, h. 12.00 noon (Italian time).

Candidates shall submit:

Evaluation

Up to 100 points, specifically:

For qualifications, publications and possible tests, from 0 to 60;

For interview, from 0 to 40.

The following qualifications are considered as evaluation criteria:

- a) Specialization diplomas and certificates of attendance of post-graduate specialization courses, obtained both in Italy and abroad, in subjects related to the research field and other academic titles;
- b) Publications (a list) and electronic submission of at least of 2 publications (in PDF format), which will be evaluated by the commission;
- c) Documented research activity with private or public subjects in Italy or abroad;
- d) Documented periods of ethnographic research;
- e) Documented collaboration with international and interdisciplinary research groups;
- f) attached 'preferential securities', if the candidate possesses them - see Article 5 of the competition available in Italian ([link](#));
- g) any other element provided for the announcement, to the articles 2, 3 and 5 of the competition available in Italian ([link](#)).

The interview aims to assess the candidates' skills and expertise on the following subjects:

- Familiarity with the following research fields: ethology, applied ethology; mammalogy, animal welfare and behaviour;
- Language proficiency in both English and Spanish.

At the end of his/her research activity, the research fellow is required to provide the Department with:

- Research report in preparation of an article;
- Fieldwork results presentation in an international seminar;
- Visual documentation;
- Presentations of book and articles reviews in internal seminars.
