Research fellowship on Universalism and rights of man. Description

The Department of Linguistic and Comparative Cultural studies at Università Ca' Foscari Venezia invites applications for a fellowship in:

Title: Universalism and rights of man. Preparation of the Italian edition of Idee per la filosofia della storia dell'umanità [Ideen zur Philosophie der Geschichte der Menschheit/ Ideas for the philosophy of the history of mankind] by di Johann Gottfried Herder

Scientific area: L-LIN/13, M-STO/02, M-FIL/06

Abstract:

The project aims to write the critical apparatus (notes and glossary) that will accompany the publication of the first complete Italian translation of Herder's Ideen, as to this day only an anthological selection, without annotations, has been published by Laterza in 1992. The research will therefore need to trace and examine the direct and indirect sources of Herder's writing, his explicit and implicit references, polemical intentions; it will also need to highlight the semantics of the rights that the author uses in different parts of the work and in the variations of the editions, in order to compile a critical apparatus that, with a particular attention to the theme of universalism, allows the reader to understand the innovation that the Ideen have introduced into the language on rights, universalism, and cosmopolitanism in the modern age.

The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

Who can apply

Prospective candidates are expected to hold a master's degree in Filosofia, or related disciplines.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar.

Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

Duration of contract: 12 months (approximately starting: 1st June 2024).

Stipend: The research fellowship amounts to 19,367 Euros per year, including taxes and social charges.

Evaluation

Up to 100 points, specifically:

For qualifications, publications and possible tests, from 0 to 60;

For interview, from 0 to 40.
