Research fellowship on "Cultural events legacy creation: the balance between innovation, tradition and sustainability" - Università Ca' Foscari Venezia (Italian law 30 December 2010, n. 240, art. 22 and subsequent amendments and additions).

Description

The Department of Management at Università Ca' Foscari Venezia invites application for one-year fellowship in "Cultural events legacy creation: the balance between innovation, tradition and sustainability", under the supervision of prof. Francesco Casarin (SECS-P/08 - Management).

Abstract: This project starts from a medium-long term reflection on how it is becoming increasingly important to be able to maximize the positive effects over time deriving from a cultural event. In event evaluation, traditionally only short-term impacts are measured and analyzed.

The objective of this research is the study of those dimensions of innovation, tradition and sustainability of a cultural event that can have medium-long term economic, social and environmental impacts. Through an integrated methodological approach that combines qualitative and quantitative analyses, the research aims to obtain an indepth understanding of the dynamics of events through the involvement of both organizers and participants. Significant managerial implications will arise from this which could constitute new business models for the creation of exhibitions and festivals with more incisive effects on the territory, investors, the tourism sector, and also new resources for the well-being of residents.

The research may be carried out in Italian and English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

Who can apply

Prospective candidates are expected to hold a master's degree in Economics (LM-56) or equivalent and scientific-professional curriculum suitable to the development of research activities related to the fellowship.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar.

Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

Duration of contract: 12 months (approximately starting: September 2024), with the possibility of renewal within the limits of art. 2 of the Regulations on university research fellowship awarding, which will be subject to a specific contract.

Stipend: The research fellowship amounts to **19.367,00** *Euros* **per year**, including taxes and social charges depending on applicant's filing status (cost to Ca' Foscari € 24.000,00).

Deadline for submission of applications: July 08th 2024, 12 noon (Italian time).

How to apply:

Candidates shall submit:

- 1. The application form;
- 2. A motivation letter (max 1 page) along with their CV in European format, duly dated and signed, both to enclosed as a one single.pdf file (link); a declaration must be appended in the footnote of the curriculum, pursuant to the Italian DPR 445/2000 and subsequent amendments and additions, that the information provided corresponds to the truth. Moreover the candidates have to consent to the use of their personal data for the purposes of this selection procedure pursuant to the Italian Legislative Decree 196/2003 and to the EU Regulations 2016/679;
- 3. The attachments called "obligations and understanding" and "participation and compatibility";
- 4. All documents, qualifications and publications relevant for the selection procedure (please, see the notice <u>link</u>);



- 5. A copy of a valid identity document (either Identity Card or Passport);
- 6. (If available) Evaluation Summary Reports of Marie Skłodowska Curie Actions Individual Fellowships/ ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) individual proposals having passed all the evaluation thresholds;

Evaluation

The evaluation takes into account the criteria and thresholds described in the table below.
