Research fellowship on "Financing Italian agrifood transition: Reconciling old barriers with digital & sustainable pathways" - Università Ca' Foscari Venezia (Italian law 30 December 2010, n. 240, art. 22 and subsequent amendments and additions).

Description

The Department of Management at Università Ca' Foscari Venezia invites application for one-year fellowship in **Financing Italian agrifood transition: Reconciling old barriers with digital & sustainable pathways**, under the supervision of Giorgio Stefano Bertinetti, co-tutor Anastasia Giakoumelou (ECON-09 – Corporate Finance).

Abstract: Making up for more than 4% of the Italian GDP, a total €64 bn worth of exports in 2023 (registering a 6% growth from the year before) and more than 1.000.000 companies that span from agricultural to detail sales, the agri-food sector is rightly considered pivotal. However, although quality and a robust connection to culture, both domestically and abroad, have long been rooted in consumers' and investors' perception, the sector's journey has been far from smooth in recent times. In an international, highly competitive environment, the Italian agri-food sector appears linked to excellence, more sustainable than many counterparts (including Germany or Spain and several other western economies) and heavily investing in innovation (Agrometeorologia, Big Data, Blockchain, Cloud, Drones, Connected Device, AI, Internet of Things, Farm management information system), but at the same time less financially competitive. The latter may be due to several characteristics that span from an ample fragmentation, severe operational and cost inefficiencies, and low financialization of the players. The aforementioned lead to a sector that is presently afflicted by low returns, long investment payback periods and simultaneous, large-scale innovation investments that further hinder short-term performance. The Italian agri-food players appear to face much lower access to a wide spectrum of financing alternatives: bonds and mini-bonds, crowdfunding, ESG-linked securities and loans, institutional investors and developing alternative investor classes.

This research will explore the aforementioned dynamics, in order to map the current environment before delineating potential remedies to finance the Italian agri-food sector's sustainable transition and innovation journey

The research may be carried out in Italian and English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

Who can apply

Prospective candidates are expected to hold a master's degree in Economics, Management and scientificprofessional curriculum suitable to the development of research activities related to the fellowship.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar.

Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

Duration of contract: 12 months (approximately starting: September 2024), with the possibility of renewal within the limits of art. 2 of the Regulations on university research fellowship awarding, which will be subject to a specific contract.

Stipend: The research fellowship amounts to **19.367,00** *Euros per year*, including taxes and social charges depending on applicant's filing status (cost to Ca' Foscari € 24.000,00).



Deadline for submission of applications: August 23rd 2024, 12 noon (Italian time).

How to apply:

Candidates shall submit:

- 1. The application form;
- 2. A motivation letter (max 1 page) along with their CV in European format, duly dated and signed, both to enclosed as a one single.pdf file (<u>link</u>); a declaration must be appended in the footnote of the curriculum, pursuant to the Italian DPR 445/2000 and subsequent amendments and additions, that the information provided corresponds to the truth. Moreover the candidates have to consent to the use of their personal data for the purposes of this selection procedure pursuant to the Italian Legislative Decree 196/2003 and to the EU Regulations 2016/679;
- 3. The attachments called "obligations and understanding" and "participation and compatibility";
- 4. All documents, qualifications and publications relevant for the selection procedure (please, see the notice <u>link</u>);
- 5. A copy of a valid identity document (either Identity Card or Passport);
- 6. (If available) Evaluation Summary Reports of Marie Skłodowska Curie Actions Individual Fellowships/ ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) individual proposals having passed all the evaluation thresholds;

The evaluation takes into account the criteria and thresholds described in the table below.
