







# Research fellowship on "Preroman necropolis of Padua: a case of proto-urban society development"—Department of Humanities Ca' Foscari University of Venice

#### **Description**

The Department of Humanities at Ca' Foscari University of Venice (Dipartimento di Studi Umanistici dell'Università Ca' Foscari Venezia) invites applications for a fellowship in: "Preroman necropolis of Padua: a case of proto-urban society development" - ARCH-01/C Civilizations of Pre-Roman History and Etruscology, Cod. GSD 10/ARCH-01 (vd. DM 639/2024), duration 12 months, tutor Prof. Giovanna GAMBACURTA, financed by PRIN 2022 - Missione 4 "Istruzione e Ricerca" del Piano Nazionale di Ripresa e Resilienza ed in particolare la componente C2 – investimento 1.1, Fondo per il Programma Nazionale di Ricerca e Progetti di Rilevante Interesse Nazionale (PRIN) project: "20228KR93P - FAmilies, Gender, Mobility and Interculturalism in the etrusco-italic necropolis. Some cases from Campania and Veneto (FaGeMI)", CUP: H53D23000080006, Principal Investigator Prof. Giovanna GAMBACURTA.

**Abstract:** The research involves the systematic study of burials from the southern and eastern necropolises of pre-Roman Padua, belonging to groups significant for the funerary representation of family aggregations or social proximity. The researcher will have to study the materials from the point of view of chronotypology and funerary ritual, matching the results with basic and advanced anthropological analyses, and take into account anthracological analyses where available. The aim is to define socially significant families groupings pertaining to the 9th-7th centuries, in relation to the development of the proto-urban centre and their possible allochthonous provenance. In the course of this study, the assignee will have to organise interdisciplinary analyses and relate to the anthropological scholars involved in the project.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Ca' Foscari University of Venice.

### Who can apply

Prospective candidates are expected to hold a master's degree and a suitable scientific / professional track record.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar.

Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

**Duration of contract:** 12 months (approximate starting date: 15<sup>th</sup> September 2024)

Stipend: The research fellowship amounts to 19.367,00 Euros, including taxes and social charges.

Deadline for submission of applications: 22<sup>nd</sup> August 2024, h. 12.00 noon (Italian time).

## How to apply:

Candidates shall submit:

- 1. The application form;
- 2. A motivation letter (max 1 page) along with their CV in European format, duly dated and signed, both to enclosed as a one single.pdf file (link); a declaration must be appended in the footnote of the curriculum, pursuant to the Italian DPR 445/2000 and subsequent amendments and additions, that the information provided corresponds to the truth. Moreover the candidates have to consent to the use of their personal data for the purposes of this selection procedure pursuant to the Italian Legislative









Decree 196/2003 and to the EU Regulations 2016/679;

- 4. All documents, qualifications and publications relevant for the selection procedure (please, see the notice link);

## **Evaluation**

Up to 100 points, specifically: For qualifications, publications and possible tests, from 0 to 60; For interview, from 0 to 40.

The following qualifications are considered as evaluation criteria:

- a) a PhD, or the completion of a PhD course pending graduation;
- b) list of publications on research topics;
- c) electronic submission of a maximum of 3 publications (in PDF format);









- d) Specialization diplomas and certificates of attendance of post-graduate courses, obtained both in Italy and abroad, with particular reference to the themes of pre-Roman Veneto; the carrying out of documented research activities at public and private entities with contracts, research grants, scholarships or assignments both in Italy and abroad with particular reference to excavations in funerary contexts. attached 'preferential securities', if the candidate possesses them - see Article 5 of the competition available in Italian (link);
- e) any other element provided for the announcement, to the articles 2, 3 and 5 of the competition available in Italian (link).

The interview aims to assess the candidates' skills and expertise on the following subjects:

- Knowledge of the chronotypology of materials from pre-Roman Veneto, particularly from the Early Iron Age;
- Expertise in the themes of funerary rituals in pre-Roman Veneto;
- Attention to the specific issues of cremation in the context of funerary rituals;
- English language

At the end of his/her research activity, the research fellow is required to provide the Department with:

- One paper in scientific and/or class A journals
- One conference
- A scientific catalogue of the burials involved in the PRIN, selected by the PI

#### Selection procedure

The interview will be on 9<sup>th</sup> September 2024, h. 09:00 a.m. The interview will be held in remote with Google Meet.
