Research fellowship on "The transformations of the Italian automotive ecosystem in light of the evolution of technology and the market" - Università Ca' Foscari Venezia (Italian law 30 December 2010, n. 240, art. 22 and subsequent amendments and additions).

Description

The Department of Management - Venice School of Management at Università Ca' Foscari Venezia invites application for one-year fellowship in *The transformations of the Italian automotive ecosystem in light of the evolution of technology and the market*, under the supervision of prof. Francesco Zirpoli (ECON-07/A - Management).

Abstract: This project is part of the OTEA Observatory at VSM - Ca' Foscari University of Venice that aims to investigate the impact of the ongoing technological transition on employment and professional skills in the automotive sector. It is founded on the integration of various disciplinary expertise, including the sociology of work and organizations, economic sociology, and innovation management, along with a combination of qualitative surveys and data sets as methodological approaches. The candidate will work on the following research question: How are changes in the knowledge base and market impacting the Italian automotive industry's supply chain and its professional and occupational needs?

The research may be carried out in Italian and English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

Who can apply

Prospective candidates are expected to hold a doctoral degree in Management, Economics and scientificprofessional curriculum suitable to the development of research activities related to the fellowship.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar.

Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

Duration of contract: 12 months (approximately starting: December 2024), with the possibility of renewal within the limits of art. 2 of the Regulations on university research fellowship awarding, which will be subject to a specific contract.

Stipend: The research fellowship amounts to **23.240,00** *Euros per year*, including taxes and social charges depending on applicant's filing status (cost to Ca' Foscari € 28.668,00).

Deadline for submission of applications: October 28th 2024, 12 noon (Italian time).

How to apply:

Candidates shall submit:

- 1. The application form;
- 2. A motivation letter (max 1 page) along with their CV in European format, duly dated and signed, both to enclosed as a one single.pdf file (link); a declaration must be appended in the footnote of the curriculum, pursuant to the Italian DPR 445/2000 and subsequent amendments and additions, that the information provided corresponds to the truth. Moreover the candidates have to consent to the use of their personal data for the purposes of this selection procedure pursuant to the Italian Legislative Decree 196/2003 and to the EU Regulations 2016/679;
- 3. The attachments called "obligations and understanding" and "participation and compatibility";
- 4. All documents, qualifications and publications relevant for the selection procedure (please, see the notice link);
- 5. A copy of a valid identity document (either Identity Card or Passport);

Evaluation

The evaluation takes into account the criteria and thresholds described in the table below.
