Description

The “Centro temporaneo Progetto CHANGES” at Università Ca' Foscari Venezia invites applications for a fellowship in:

Title: Community, Archeologies, and Narratives: Participatory tools for sustainable solutions overtourism areas

SSD or Research sector: ARCH-01/F - ARCH-01/G

Scientific coordinators or supervisor: Prof. Diego Galaon, Prof.ssa Monica Calcagno

Duration: 12 months

Abstract: The research path is linked to the activities of Spoke 9, particularly for the pilot projects in archaeology. The ideal candidate should be able to support the researchers in the group in the analysis and implementation of test solutions for the active participation of communities and citizens in areas marked by overtourism. The actions will be inspired by the principles of the Faro Convention and the theoretical indications of the construction of cultural heritage identity by Laurajane Smith and Rodney Harrison. The actions and the theoretical evaluation of the proposed actions will be carried out using qualitative methods, which include anthropological fieldwork and data collection experiences during specific moments of community building.

The research will attempt to qualitatively assess the short-term impact of actions that center on the narratives of people versus the narratives of institutions. Furthermore, the research will aim to experiment with narrative reversals regarding the significance of archaeology in the selected areas.

The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar.

Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

The following are considered preferential qualifications:

- A. a PhD;
- B. postgraduate diplomas and certificates of attendance at postgraduate courses, whether obtained in Italy or abroad;
- C. research experiences testifying to skills acquired in fields related to the conservation and management of cultural and landscape heritage such as: academic publications on topics related to the enhancement of cultural heritage; collaborations in research projects centered on the same topics; participation in national and international conferences on the same topics; university teaching experiences;
- D. professional experience related to land management and preservation such as: preventive archaeology activities, restoration and recovery interventions of architectural heritage, design of/collaboration in programs of land monitoring and preservation also in a participatory way;
- E. experience with tools and methodologies related to land use planning, conservation of cultural heritage, and citizen participation projects in the preservation and enhancement of cultural/landscape heritage.

Duration of contract: 12 months (approximately starting in November 2024)

Stipend: The research fellowship amounts to 30.000,00 Euros per year gross percipient, net of charges to be borne by the institution.

Deadline for submission of applications: October 25, 2024 noon CET

How to apply:

Candidates shall submit:

Moreover, the candidates have to consent to the use of their personal data for the purposes of this selection procedure pursuant to the Italian Legislative Decree 196/2003 and to the EU Regulations 2016/679;

Evaluation

Up to 100 points, specifically:

For qualifications, publications and possible tests, from 0 to 60;

For interview, from 0 to 40.

Selection procedure

The interview will be on **November 04, 2024**. The interview will be held in remote.

The short-list of the candidates admitted to the interview, or any postponement, will be published on the University's webpage on **October 29, 2024** ([link](#)).

It is the candidate's responsibility to check the admission results and, if admitted, to show up at the required date and time.

The interview may ascertain knowledge of the following topic:

- Notions and theoretical approaches on cultural heritage
- Conservation, enhancement and participation: theories and methods before and after the Faro Convention
- Sustainability in conservation projects: environmental, economic and social
- Sustainable and participatory tourism models: policy implications
