### **Description**

The "Centro temporaneo Progetto CHANGES" at Università Ca' Foscari Venezia invites applications for a fellowship in:

**Duration**: 12 months

**Abstract:** The culture of territories is a fundamental resource for the enhancement of sustainable tourism models. To patrimonialize the landscape and cultural resources of a territory means not only to recognize their exceptional and unique value through the assessment of a national or supranational institution but also, and above all, to characterize them as elements of significance for the members of the communities that experience them in their daily lives.

From this perspective, tourism should not be a simple phenomenon of "consumption" of culture; rather, it should be integrated into the shared process of creating narratives and meanings that emerge from certain cultural resources. Such meanings, although typically associated with the history of a territory and the intrinsic aesthetic connotation of each cultural asset, are constantly (re)constructed by the various actors who actively engage with that territory.

The project aims to identify, define, and analyze participatory methods and approaches for the enhancement of cultural and landscape heritage that can successfully combine the nurturing processes through which communities continuously infuse meaning into their cultural resources with the living experience of tourists, which can help transform those processes of signification into economic development of the territories

The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar.

Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

The following are considered preferential qualifications:

- A. a PhD;
- B. research experiences testifying to skills acquired in areas related to the conservation and management of cultural and landscape heritage such as: academic publications on topics related to the enhancement of cultural heritage; collaborations in research projects centered on the same topics; participation in national and international conferences on the same topics; university teaching experiences;
- C. professional experiences related to land management and conservation such as: preventive archaeology activities, restoration and recovery interventions of architectural heritage, design of/collaboration in land monitoring and preservation programs also in a participatory way;
- D. experience with tools and methodologies related to land planning, conservation of cultural heritage, projects for citizen participation in the preservation and enhancement of cultural/landscape heritage.

**Duration of contract:** 12 months (approximately starting in November 2024)













**Stipend**: The research fellowship amounts to 30.000,00 Euros per year gross percipient, net of charges to be borne by the institution.

# How to apply:

Candidates shall submit:

A motivation letter (max 1 page) along with their CV in European format, duly dated and signed, both to enclosed as a one single.pdf file (link); a declaration must be appended in the footnote of the curriculum, pursuant to the Italian DPR 445/2000 and subsequent amendments and additions, that the information provided corresponds to the truth. Moreover, the candidates have to consent to the use of their personal data for the purposes of this selection procedure pursuant to the Italian Legislative Decree 196/2003 and to the EU Regulations 2016/679;

#### **Evaluation**

Up to 100 points, specifically:

For qualifications, publications and possible tests, from 0 to 60;

For interview, from 0 to 40.

#### Selection procedure

The interview will be on November 04, 2024. The interview will be held in remote.

The short-list of the candidates admitted to the interview, or any postponement, will be published on the University's webpage on **November 05, 2024** (<u>link</u>).

It is the candidate's responsibility to check the admission results and, if admitted, to show up at the required date and time.

The interview may ascertain knowledge of the following topic:

- Notions and theoretical approaches on cultural heritage
- Conservation, enhancement and participation: theories and methods before and after the Faro Convention
- Sustainability in conservation projects: environmental, economic and social
- Sustainable and participatory tourism models: policy implications
