

### Decree of the Director DMAN 2021

Rep. 177, prot. 11295 del 16/2/2021

Subject: Comparative procedure for the identification of a resource to be entrusted with an independent work assignment to support the activities aimed at the realization of the exhibition "ODYCCEUS Acqua Granda" as part of the ODYCCEUS - G.A. n. 732942 CUP H72F16000760006 H2020 - FETPROACT-2016-2017 RIA, WP 8 project – scientific director Massimo Warglien.

#### THE DIRECTOR

- GIVEN the project "ODYCCEUS Opinion Dynamics and Cultural Conflict in European Spaces", G.A. n. 732942 of 26/10/2016, CUP H72F16000760006 H2020 – FETPROACT 2016-2017 RIA, scientific director Massimo Warglien;
- GIVEN the request of professor Warglien of 3/2/2021 to launch a selection process for the conferment of an independent work assignment for support activities aimed at the realization of the exhibition "ODYCCEUS Acqua Granda", as part of the same project, in particular for the WP 8;
- GIVEN the Legislative Decree n. 165/2001, art. 7 and subsequent amendments;
- GIVEN the Law n. 232 of 11/12/2016, art. 1, paragraph 303, which states, starting from 2017, that the acts and contracts referred to in art. 7, paragraph 6 of the Legislative Decree n. 165 of 30/03/2001, stipulated by state Universities, are not subject to the control of legitimacy of the Court of Auditors pursuant to law n. 20/1994 (art. 3, paragraph. 1, letter f-bis);
- GIVEN the University Statute, issued with D.R. n. 750 of the 8<sup>th</sup> of September 2011, pursuant to art. 2 c. 5 of the Law of the 30<sup>th</sup> of December 2010;
- GIVEN the University Regulations for the conferment of assignments to subjects external to the University (D.R. n. 321 of 22/04/2014);
- GIVEN the University Regulations for administration, finance and accounting;
- GIVEN the 2021 Departmental budget approved by the Council of the Department during the 21/10/2020 session and the subsequent changes to it;
- GIVEN the 2020 budget forecast, approved by the Board of Directors in the meeting of 18/12/2020;
- RECALLING the decree of the DMAN Director n. 65/2017 for the creation of the MAN.ODYCCEUS project for the management of the funds assigned to the Department as part of the implementation of the research activities of the project itself;
- VERIFIED THAT the financial availability to cover the estimated expenditure for the four assignments estimated at a total of € 7,000.00 (cost of the institution) is to be charged to the UE.A.DP.MAN.ODYCCEUS project, item COAN A.C.03.07.03.01;
- CONSIDERED that the Project's activities will cease at the end of June 2021 and the urgency to recruit the resources in question and allow the activities to be completed in time to meet this deadline;

#### **PROVIDED THAT**

- the University guarantees equal opportunities between men and women for the conferment of the position advertised by this notice;

#### DECREES THAT

Art. 1 Calling - The calling of a curriculum-based comparative procedure is authorized, it is aimed at ascertaining the existence within the University of a resource available for carrying out, within the contractual institutions provided for the University sector, the support activities

Dipartimento di Management segreteria.management@unive.it aimed at the realization of the exhibition "ODYCCEUS Acqua Granda" and, if the verification gives a negative result, the calling is then aimed at regulating the identification of external subjects by comparing each curriculum with the professional profile required.

### Art. 2 Context, subject matter of the assignment, period Context

On 12 November 2019, Venice suffered a catastrophic weather event, called Acqua Granda. On that evening, due to the particularly adverse weather conditions, the city suffered an extraordinary tide peak, enormously raising the water level inside Venice, reaching 190 cm above the sea level.

High water is common in the autumn and spring season, and inevitably floods between 14% and 70% of the city.

But the Acqua Granda, with a tidal peak that exceeds 180 cm and submerges 80% of the city, is even more devastating and so far a fairly rare event. A similar situation is found again on November 4, 1966. These events have a huge impact on the city and its population: they cause the destruction of transport infrastructure, shops, private homes, monuments, equipment, libraries and laboratories. They undermine the economy, especially the tourism-based sectors, and other important city activities, such as the university or the hospital. They have a great impact on the mood of citizens, on the livability of the city already severely damaged by mass tourism and on the ecological sustainability of the lagoon.

The exhibition scheduled for April 2021 and was envisioned as an event for the dissemination of the results achieved within the European project "ODYCCEUS. Opinion Dynamics and Cultural Conflict in European Spaces" G.A. n. 732942 - Amendment AMD-732942-17, CUP H72F16000760006 H2020-FETPROACT-2016-2017 RIA, remembers the Acqua Granda event of 2019, seen through social media. Citizens, visitors and international commentators have posted a large amount of messages, audio and video clips on social media, reporting their experiences of the event and its consequences, reacting and discussing the causes. what should be done to repair the damage in the short term and how another catastrophe can be averted in the long run. This huge dataset gives us a unique and profound trace of how the local and international community has reacted. The messages talk about the effects of climate change, the ecological mismanagement of the lagoon, the Bora and Scirocco winds, the corruption and political indecision that delayed the mechanical barrier of MOSE, the collapse of tourism, as well as personal experiences and of the desperation of the citizens who defend and lament the damage to their homes, and of the international regret for the loss of the unique European cultural heritage found in Venice. All these materials were collected in a digital archive collected by the Ca' Foscari University (Department of Management) as part of the European project H2020 **ODYCCEUS** (https://www.odycceus.eu/).

The ODYCCEUS project also developed a wide range of tools to analyze social media data and to visualize the result of this analysis. These scientific methods not only give a unique insight into this particular event, but also help us understand the general dynamics by which information propagates in social communities, opinions are formed, and antagonisms arise and develop in social media. The exhibition is in collaboration with the Ca' Foscari University Foundation and Science Gallery.

### **Object of the assignment**

The goal of the residence is to work with the *Acqua Granda* Digital Community Memory archive constructed as part of the ODYCCEUS project in collaboration with the Ca' Foscari University Foundation and Science Gallery Venice, and to investigate possible ways in which it can be made accessible to local citizens and the international community, possibly by using the Penelope tools developed in the ODYCCEUS EU Project. The developing of new ideas for the continued existence and expansion of the archive are also encouraged. The result of the residence should be a contribution towards the ODYCCEUS Acqua Granda exhibition that will start at the end of April.

### Period

A maximum commitment of two months is envisaged for the activities described, which will begin after the signing of the contract.

The modality for carrying out the activities will be agreed on with the collaborator, in close relationship with the scientific director and the Department Secretary.

#### Art. 3 Requirements and selection results

We are looking for a senior professional with multiple years of experience:

- with a track record of work on scientific or photographic archives and of making them public through artistic means of communication (exhibitions, videos, photography, text);
- in possession of a Bachelor's Degree (DM 270/04)/old system (prior to Ministerial Decree 509/1999) in the field of natural sciences and who has attended a public or private school for training in the arts, with particular reference to visual media (photography and cinema).

Previous experience relating to the issues of the emergency of climate change, social media and language represent a preferential criterion.

Academic qualifications obtained abroad will be examined by the Commission, refer to the following art. 7, which may consider them equivalent for the purposes of admission, without prejudice to current legislation on the subject.

The results of the comparative procedure announcing the successful candidate will be published on the Ca 'Foscari University website at <u>http://www.unive.it/data/12108/</u> on **8/3/2021** as well as in the Official University On-line Register, both if the outcome is a consequence of internal recognition, and if an external candidate has been identified. - Art. 4 Application procedure for internal candidates For the purposes of internal recognition, the technical administrative staff of the University may apply if holders of an open-ended contract with full-time hours and if in possession of the following requirements, on temporary secondment of maximum two months:
  - with a track record of work on scientific or photographic archives and of making them public through artistic means of communication (exhibitions, videos, photography, text);
  - in possession of a Bachelor's Degree (DM 270/04)/old system (prior to Ministerial Decree 509/1999) in the field of natural sciences and must have attended a public or private school for training in the arts, with particular reference to visual media (photography and cinema).

The application, composed on plain paper following the attached scheme (attachment 1) and accompanied by curriculum vitae in Europass format and a portfolio illustrating previous artistic experiences (both signed), and authorized by the Director of the candidate's university structure of belonging, must be sent directly to the Management Department **no later than 12.00 on 3/3/2021.**

Applications will be assessed by the head of the Management Department by evaluating the curricula in compliance with the duties the selected candidate is expected to carry out,

provided for by art. 52 of Legislative Decree no. 165/2001 and the current University Regulations for the conferment of assignments to subjects external to the University (art. 13). In the event of a positive outcome of the assessment, for the purpose of assigning the identified technical-administrative staff on partial transfer, the head of the Management Department will send a formal request, in the manner provided, to the A.R.U, which will arrange for the assignment.

Art. 5 Application procedure for external subjects - Subjects external to the University in possession of the requirements referred to in the following art. 6 may apply for their consideration during the comparative procedure.

The application for admission to the comparative procedure, accompanied by their curriculum vitae in Europass format, and a portfolio illustrating previous artistic experiences (both signed) to be drawn up on plain paper following the attached scheme (annex 2), must be sent to the Department of Management of Ca' Foscari University of Venice in S. ### Art. 6 Admission requirements - Candidates must be in possession of the following requirements by the deadline for submitting applications:

- No former criminal convictions which resulted in the inability to contract with the Public Administration as an ancillary order;

- The absence of any degree of kinship or affinity, up to and including the fourth degree, with the Rector, the General Manager or the Director of the Management Department;

The Commission will evaluate the applications for participation in the selection according to the evaluation criteria set out in this notice.

The comparative evaluation of the curricula will be carried out on the basis of what is declared in the application and in the curriculum produced by the candidates.

Art. 8 Evaluation criteria - The evaluation of the cultural and professional qualifications indicated in the curriculum vitae will be carried out on the basis of the following criteria:

Long-standing years of experience documented both nationally and internationally regarding the subject-matter of the assignment described in this notice:

- qualitative assessment of the activity (prestige and relevance of the institutions involved, innovativeness of the topics covered, originality of the tools and proposed solutions): maximum 15 points;

- evaluation of the pertinence of the documented activities with respects to the project assignment: maximum 10 points;

- evaluation of the international extension of the activity (intensity of collaboration with foreign partners): maximum 5 points;

- Art. 9 Evaluation result This evaluation does not give rise to suitability judgments. At the end of the recognition and comparison procedure, the Commission draws up a report indicating and motivating the result of the evaluation and identifying the chosen candidate.
- Art. 10 Form of contract and expected remuneration At the end of the procedure, a selfemployment contract will be stipulated with the selected candidate for a maximum duration of two months, starting after the signing of the contract, for a compensation of € 5.350,00 (five thousand three hundred and fifty / 00) to be understood as an amount gross of withholding taxes payable by the recipient.

# The amount is to be understood as inclusive of any costs related to the performance of the activity envisaged by the assignment in question.

The compensation due will be paid upon conclusion of the contract and after verification of the activity performed.

The selected candidate will be entitled to 10 pages in the exhibition catalog.

If the identified collaborator is an employee of another Public Administration and subject to the authorization regime pursuant to art. 53 of Legislative Decree 30 March 2001 n. 165 must submit the authorization of the administration to which they belong before entering into the contract.

The University reserves the right not to proceed with the signing of the contract if, for any reason, the need, the possibility, the interest, the financial coverage or the convenience to stipulate the contract cease to exist.

Art. 11 Intellectual Property - Ca 'Foscari University - Department of Management will be the exclusive owner of all rights concerning any material prepared in relation to the assignment, with the sole exception of moral copyright, if applicable. Ca' Foscari University - Department of Management may therefore freely dispose of them as part of its activities and within the activities of the University.

The selected person must also guarantee that any prepared material does not violate the rights of third parties, including, among other things, copyrights, patents, trademarks, distinctive signs, industrial secrets, rights deriving from contracts or licenses, and must guarantee to indemnify and hold Ca' Foscari University - Department of Management not accountable from any claim, request for reimbursement or compensation that may be advanced by third parties due to the infringement of these rights.
