The Board can attribute a maximum of 100 points to the evaluation of qualifications, CVs and attached documents and for the interview.

The Board can attribute a maximum of 40 points, distributed as defined below, for the evaluation of qualifications, CVs and attached documents.

The Board specifies the criteria synthetically provided above and establishes the evaluation structure for qualifications, CVs and documents attached:

The Board decides to evaluate the coherence of the qualifications with the profile by analyzing the CVs with regard to the Degree(s) possessed and the assessment of the study program (if applicable). The Board decides to assign the following scores,
up to 30 points:
 5 points for the Degree 7 points for the Degree in subjects related to the research to perform max 3 points for other academic qualifications in subjects related to the research to perform (e.g. master, PhD)
The Board decides to evaluate skills and experiences on the basis of the statements in the CVs and the attached documents. In particular, a maximum of 13 points is attributed to the skills and a maximum of 12 points to professional experiences.
In particular, the Board attributes the following points:
 12 points for professional experiences in the field of financial risks, Fintech and bank-firm relationship; 13 points for skills, in particular related to research activities, in the field of financial

The Board establishes that on the basis of the evaluation and comparison of qualifications, CVs and the attached documents, the selection for the access to the interview is passed in the event that the candidate gets a minimum score of 30 points.
