The evaluation of the scientific and professional qualifications will be in conformity with the requirements deemed necessary for carrying out the research activities.

The Selection Committee can assign a maximum **grade up to 100 points** for the evaluation of the scientific and professional qualifications and CV.

Evaluable Qualifications (max 40 points)	<p>The Commission decides to evaluate the consistency of the training with the profile sought by analyzing the CV proposed by the candidate in relation to the qualification held and any qualifications obtained:</p> <ul style="list-style-type: none">- Max 18 points: Master's degree or equivalent qualification obtained abroad in anthropological, sociological or folklore subjects, in fields relevant to the profile sought;- Max 2 points: for possession of qualifications higher than a Master's degree in the scientific-disciplinary fields pertaining to the research in question (e.g. master's, research doctorate);- Max 20 points: other qualifications (publications, conferences, presentations).
