The evaluation of the scientific and professional qualifications will be in conformity with the requirements deemed necessary for carrying out the research activities.

The Selection Committee can assign a maximum **grade up to 100 points** for the evaluation of the scientific and professional qualifications and CV.

The Commission decides to specify the evaluation grid for titles, CV, other documents produced by the applicants, as follows:

Expertise, experience and publication relevant to the topics of the Call ( <b>max 60 points</b> )	<p>The Examination Board shall decide to assess the skills, expertise, and competencies based on the information contained in the CV proposed by the candidate and in the attached documentation. In particular, it shall assign:</p> <ul style="list-style-type: none"> <li>- <b>Max 30 points:</b> International experience in research, teaching and professional work on the management of culture and creative industries;</li> <li>- <b>Max 30 points:</b> Publication record in the field of culture and creative industries management.</li> </ul>

<b>MINIMUM THRESHOLD FOR OVERALL ELIGIBILITY</b>	<b>60</b>
