The Commission is summoned to determine the evaluation criteria, before examining the documentation produced by the candidates.

The evaluation of the scientific and professional qualifications will be in conformity with the requirements deemed necessary for carrying out the research activities.

The Selection Committee can assign a maximum **grade up to 100 points** for the evaluation of the scientific and professional qualifications and for the interview.

The Commission decides to specify the evaluation grid for titles, CV, other documents produced by the applicants and for interview, as follows:

 CRITERIA AND MAXIMUM SCORE
 DETAILED ASSIGNMENT OF SCORES

 Evaluable Qualifications (Max 10 points)
 The Commission decides to assess the coherence of the training with the profile sought by analysing the CV proposed by the candidate about the qualification held and any further qualifications obtained:

 Max 8 points: Bachelor's degree or Master's degree or equivalent title according to the Italian law, or equivalent qualification obtained abroad in Economics or Business studies, in the scientific-disciplinary fields relevant to the research in question;

	- Max 2 points: for possession of additional qualifications other than a Master's degree in the scientific-disciplinary fields relevant to the research in question (e.g., master's degree, PhD);
Skills, expertise, and competencies relevant to the topics of the Call (Max 30 points)	The Commission decides to assess the skills, expertise, and competencies based on the information contained in the CV proposed by the candidate and in the attached documentation. In particular, it shall assign:
	- Max 10 points: Research activities and professional experiences related to the agrifood sector;
	 Max 10 points: Organizational skills for support in the management of teams of professionals and events; Max 10 points: Research activities through qualitative methodologies;
Interview (Max 60 points)	 The Commission decides to assign during the interview: Max 38 points: for the knowledge and skills illustrated by the candidate during the interview for carrying out the research activities required by the project. In particular, the following knowledge and skills will be discussed: knowledge of qualitative research methodology; organizational skills for support in the management of teams of professionals and events; experience in data collection through interviews; Max 2 points: for knowledge of the English language (at least at level A2); Max 20 points: for ascertainment of Italian language proficiency (native speaker level or C1 or higher).
