**Call for Applications for no. 1 Short-term Research Fellowship  
Ca' Foscari University of Venice – Venice School of Management**

<b>HAVING REGARD TO</b>	the Article 18, paragraph 5, letter f) of Law No. 240 of December 30, 2010, and subsequent amendments and integrations;
<b>HAVING REGARD TO</b>	the Article 21 <i>quinquies</i> of Law No. 241 of August 7, 1990, and subsequent amendments and integrations;
<b>HAVING REGARD TO</b>	Article 1 bis, paragraph 2, of Decree-Law No. 45 of April 7, 2025, as amended during conversion by Law No. 79 of June 5, 2025, which came into force on June 7, 2025, and which, in Article 4, paragraph 3, of Law No. 210 of July 3, 1998, abolished the favorable tax regime for short-term research fellowships post-graduation, establishing the application of IRPEF and IRAP taxes on such Short-term Research Fellowships;
<b>RECALLED</b>	the Regulation for the establishment of Short-term Research Fellowships for post-graduate activities pursuant to Article 18 of Law No. 240 of December 30, 2010, issued with Rectoral Decree No. 300/2014 of April 14, 2014, and subsequent amendments and integrations;
<b>WHEREAS</b>	the tax treatment of Short-term Research Fellowships is subject to the legislation in force at the time of granting. Even if not expressly referred to in this notice, the applicable tax regime will be that provided for by current legislation <i>pro tempore</i> .
<b>HAVING REGARD TO</b>	professor C. Mauracher's request concerning the awarding of no. 1 Short-term Research Fellowship entitled " <i>Strategy and innovation in Food</i> ", lasting 10 months for a total amount of 19.530,00 euros;
<b>HAVING REGARD TO</b>	the authorization of the above-mentioned request given by the School Council held on 24 June 2026;
<b>HAVING REGARD TO</b>	the assigned <b>CUP: H73C26000540005</b> ;

**Description**

**The Venice School of Management - Ca' Foscari University of Venice**, as specified in the introduction, hereby calls for applications for no. 1 Short-term Research Fellowship entitled "*Strategy and innovation in Food*", lasting **10 months – Tutor prof. C. Mauracher**.

The research fellow must perform the following research:

1. *Measure innovation, with particular reference to product development and process digitalization, among medium-sized enterprises in the food sector;*
2. *Identify the enabling and supporting factors of the innovation process;*
3. *Reconstruct the decision-making processes and the organizational and sector-specific determinants underlying the different types of innovation.*

The scientific responsible and tutor of the Short-term Research Fellowship is **prof. Christine Mauracher**.

The research fellow must provide the School with the following research output:

- **two-monthly reports** on the activities (Tot. **5 reports**);
- **a final report** on the activities undertaken, highlighting the results achieved.

This documentation is by way of example and not exhaustive and may change or be implemented according to the needs of the research activity concerning the project and/or the structure that calls for the research grant. For anything not specified in this Call, please refer to the Regulations and applicable legislation.

**Duration of the Short-term Research Fellowship: 10 (ten) months, indicatively starting in September 2026.**

**Amount:** The amount of the Short-term Research Fellowship is equal to € 18.000,00 (eighteen thousand/00 euros), gross recipient and will be subject to taxation according to the regulations in force. It will be paid in **bimonthly instalments** after certification of the regular performance of the activity. The amount awarded is understood to include any costs relating to the undertaking of the research envisaged by the project.

**The monthly amount shall only be approved and awarded for whole months completed; amounts for months not completed shall not be awarded.**

**Deadline for submission of applications: not later than noon time (12:00 Rome CET) of Wednesday, 15 July 2026.**

In case the deadline is on Saturdays, Sundays or on holidays, it is extended to the first working day thereafter.

**Who can apply?** (University Regulation for short-term research fellowships, Art. 3)

**Applications are open to all EU citizens and non-EU citizens who hold:**

- **Master's degree (or equivalent) in classe LM-77 (Scienze Economico-Aziendali) or classe LM-82 (Scienze Statistiche) or classe LM-88 (Sociologia e Ricerca Sociale) or classe LM-56 (Scienze dell'economia) (Italian Regulation) or equivalent foreign qualification.** Qualifications obtained abroad will be examined by the Committee, which may consider them as being equivalent for the purposes of admission, without prejudice to the current legislation.

**In addition, the following skills, competencies and qualifications will be assessed as rewarding:**

**Skills required:**

- **Native-level or C2 proficiency in Italian;**
- Excellent knowledge of the dynamics and complexities of the agri-food market;
- Prior research activities and professional experience relevant to the subject areas of the call, with particular reference to conducting qualitative research through interviews;
- Strong skills in drafting research reports and organizing events related to the dissemination of research activities;

**Any other evaluable qualifications:**

- PhD;
- Fellowships, research grants and research contracts, as well as other documented forms of research activities for public and private organisations;
- Publications;

**Please note that the applicant shall attach any documents, language certificates, qualifications and publications relevant for the selection procedure.**

Those who have a degree of kinship or affinity, up to and including the fourth degree, with any professor belonging to the Department or facility issuing the call, or with the Rector, the General Manager or a member of the University Board of Directors, cannot participate in the selection.

Applicants must hold all the requisites within the call deadline.

Candidates are admitted to the selection conditionally; they may be excluded from the call at any time should they fail to meet the predefined requirements, even after the selection process is complete, with just cause and notification sent to the person concerned.

**Incompatibility** (University Regulation for short-term research fellowships, Art. 12)

The Short-term Research Fellowship may not overlap with:

- other short-term research fellowships granted in any capacity, apart from those granted by national or foreign research institutes in order to integrate with periods abroad the specific activity foreseen by the work plan of the appointed fellow;
- attendance of PhD courses with scholarship and medical specialization, in Italy and abroad;
- research grants "*assegni di ricerca*" o "*incarichi di ricerca*".

Short-term Research Fellowship holders may carry out self-employed work or occasional or permanent collaborations, as long as this is coherent with the ongoing research, upon approval and on the condition that:

- does not involve a conflict of interest with the specific research activity carried out;
- does not prejudice the university, in relation to the activities carried out.

Subordinate employment contracts holders, in addition to obtaining permission by the University, must provide the authorization of their employer.

- In the specific case that the subordinate employment contract started prior to the awarding of the fellowship, compatibility with the existing employment will have to be assessed; if the assessment yields a negative result, the Short-term Research Fellowship will not be awarded; in the case of a positive result, the successful candidate will have to provide the authorization of his/her employer **within 15 days**.
- In the event that the subordinate employment contract will start once the fellowship is ongoing, the successful applicant is required to notify this change at least 30 days before the start of the employment contract for an assessment of compatibility; if the assessment is negative, the fellowship will cease by the start of the employment contract; in the event of a positive outcome, the successful applicant must provide the authorization of his/her employer **within 15 days**.

**The awarding of the Short-term Research Fellowship does not imply the establishment of any employment contract, nor does it give rise to any rights of access to positions of employment at the university.**

**How to apply** (University Regulations for short-term research fellowships, Art. 5)

**Candidates must submit:**

- a) **The application form.**

Applicants must declare in the application, under their own responsibility:

- **the possession of a Master's degree or equivalent qualification obtained abroad. Candidates in possession of a qualification obtained abroad must also submit a copy of the foreign title with a translation in Italian or English language including marks obtained, accompanied by a self-declaration relating to the conformity to the original of the translation itself.** The candidate who has been awarded a **Diploma Supplement**, may not submit any other documentation, provided that the DS provides a complete description of the nature, level, academic system and status of the studies carried out. In any case, it is advised to submit any other

document useful to the evaluation of the academic title obtained;

- nationality (the possession of a residence permit valid at the deadline of the call for applications, in case he/she is a non-European citizen residing in Italy);
- to be medically fit to discharge his/her duties for the fellowship;
- that they understand that the Short-term Research Fellowship is not compatible with the positions referred to in Art. 12 of the Regulations for Short-term Research Fellowships and current legislation;
- not to have received measures restricting personal freedom at the time of submitting the application;
- not to have a degree of kinship or affinity, up to and including the fourth degree, with any professor belonging to the department or facility issuing the call or with the Rector, the General Manager or a member of the University Board of Directors and that they are aware of the provisions of the Law no 240/2010, Art. 18, para. 1, letter b);
- any benefit under L. 104/92.

b) A **CV in European format** (Europass) **duly dated and signed**. The CV must specify the educational qualification held by the candidate and a detailed description of his/her scientific-professional qualifications.

In addition, **the CV must contain the following declarations:**

- 1) the declaration made pursuant to the Italian D.P.R 445/2000 and subsequent amendments and additions, that the information provided corresponds to the truth;**
- 2) the authorization for the processing of personal data for the purposes related to this selection procedure, made pursuant to Legislative Decree no. 196/2003 and Article 13 of the GDPR (EU Regulation 2016/679).**

c) A copy of a valid identity document (e.g. Identity Card or Passport);

d) All documents, qualifications and publications relevant for the selection procedure.

The declarations contained in the application forms and in the relevant attachments are to be considered for all legal purposes as a self-certification pursuant to articles 46 and 47 of Presidential Decree 445/2000 and subsequent amendments and additions of the data contained therein and the attached documents.

The University carries out sample checks on the truthfulness of what is declared, reserving the right to request the originals of the publications.

The untruthfulness of what is declared entails the forfeiture of any benefits resulting from the measure issued, without prejudice to the provisions of the penal code and special laws on the matter.

The mandatory deadline for submitting applications is set for **Wednesday, 15 July 2026 at 12:00 (Italian time)**.

The candidate, after the uploading, will receive a submission number and an e-mail acknowledging receipt of their application. The candidate if necessary could access the procedures for updating any data and materials through the link and submission number provided in the e-mail **until the call deadline expires**.

Incomplete applications, those without the required data and the compulsory attachments will not be taken into consideration. Furthermore, the applications which, for any reason, reach this University beyond the deadline indicated above cannot be accepted.

The declarations made in the application shall be considered issued in accordance with the DPR no. 445/2000 and subsequent amendments, by candidates entitled to use the simplified administrative certifications permitted by the above decree.

#### **Selection and Evaluation Procedure**

A Selection Committee is appointed by order of the Director of the School taking into account, whereas possible, gender balance.

The selection is made by **assessment of the scientific-professional qualifications of the candidates, followed by an interview, to be held via teleconference.**

The **interviews phase** is scheduled for **Thursday 23 July 2026, via ZOOM platform.**

**The short list of candidates admitted to the interview and eventual postponements will be published online on Tuesday 21 July 2026** on the VSM website [unive.it/management-ricerca](http://unive.it/management-ricerca)>"Research>Short-term research fellowships>Research fellowships expired calls" and on the University website "Research>Working in research>Short Term Research Fellowships>Research fellowships expired calls". The publication of the aforementioned calendar, list and announcements have the value of notification; therefore, candidates are required to present themselves, with the valid identification document presented during the application phase, on the day, the time and according to the electronic media indicated in the public notice. The absence of a candidate from the interview will be considered to all intents and purposes as a waiver.

**Please note that proficiency in Italian language will be assessed by the selection committee during the interview of admitted candidates.**

The Commission compiles a ranking and specifies the winning applicant, having regard to the score appointed to experience and qualifications, interview and any other test, as specified by the call. In the event of two or more candidates obtaining the same score at the end of the selection, the younger candidate will be preferred.

#### **Awarding of the Short Research Fellowship**

Having received the selection documents and at the outcome of the checks, the Director approves, by her decree, the ranking list and the selection procedure reports and makes them public.

Notification, including the start date of the Short-term Research Fellowship, shall be sent to the winning candidate.

**The winner must accept the Short-term Research Fellowship within seven days of receipt of the written notification referred to above, under penalty of revocation. In the event of withdrawal, the Short-term Research Fellowship shall be awarded to the next available candidate, following the order of the final ranking of merit.**

Publication of the results of all the selection phases shall be published in the online University's notice Board - Albo on line, on the VSM website [unive.it/management-ricerca](http://unive.it/management-ricerca)>"Research>Short-term research fellowships" and on the University website "Research>Working in research>Short Term Research Fellowships".

All information on the convocation of candidates will be published there, too, without further direct communication to the candidates.

Access to the selection documents is guaranteed pursuant to the law of 07/08/1990, no. 241 and subsequent amendments and additions and relative internal implementation regulation.

The Department reserves the right to cancel the procedure and/or not to proceed with the stipulation of the "Declaration of Acceptance" of the Short-term Research Fellowship with the winning person, if for any reason the interest in the research ceases.
