Position 1 Avicenna's Logic in Context: Framing the Circulation and Reception of the Logic section of Avicenna's Book of Healing

Preliminary assessment (max 60 points):

- Scientific and professional curriculum, including scientific output and research activities carried out at public and private institutions, to be evaluated with particular reference to the relevance to the research project, max 40 points:
- Consistency of the PhD path with the disciplinary field of the call max 15 points
- Relevance of the overall scientific profile to the themes of the call, with particular reference to the field of reading and analysis of Arabic manuscripts and the reconstruction of the history of their circulation max 15 points

- Prior research activities (e.g., fellowships, grants, contracts, participation in scientific activities, national or international scientific collaborations) and their consistency with the themes of the call max 10 points
- Scientific publications and other documentable research outputs, with particular reference to the relevance to the research project, max 20 points:

Up to a maximum of 5 publications will be evaluated, including the doctoral thesis. Evaluation will be based on:

- Relevance to the themes of the call
- Research approach and methodology
- Quality of the topics presented, with particular attention to the critical thinking demonstrated

Each publication may receive a maximum of 4 points; the score ranging from 1 to 4 follows the following scale:

4 points – excellent; 3 points – good; 2 points – sufficient; 1 point – insufficient

Oral Exam (max 40 points):

- Research aptitude, max 30 points:
- Aptitude for communication, argumentation, and presentation of research results max 15 points
- Scientific research skills related to the theme of the call, particularly in the field of reading and analyzing Arabic manuscripts; these skills may be assessed through a test (e.g., reading from a digital reproduction of a manuscript) max 15 points
- Assessment of knowledge of the foreign languages required by the call, max 10 points:

Classical Arabic (max 5 points)

Knowledge of Classical Arabic (reading skills) may be assessed through the reading of a passage from a medieval philosophical text. The evaluation will focus on:

- Familiarity with the analysis of syntactic and grammatical structures
- Familiarity with basic philosophical terminology

English (max 5 points)

A good working knowledge of English (written and spoken) will be assessed through a few questions related to the themes of the call and the reading of a short passage.
