INSTAGRAM CONTEST RULES #CFScienzeMolecolariNanosistemi

The Department of Molecular Sciences and Nanosystems (DSMN) - Ca' Foscari University of Venice is launching its first Instagram contest: a contest to find the 5 most representative images of the Department's degrees to be used for course presentation flyers and orientation material. To participate, please read these rules carefully: by using the hashtag #CFScienzeMolecolariNanosistemi you agree to participate in the contest according to the terms and conditions explained below.

1. Promoter identification data

2. Contest name

The contest is called #CFScienzeMolecolariNanosistemi

3. Territory

The contest takes place exclusively in the Italian territory.

4. Duration

You will be able to enter the contest from midnight on December 1, 2021 to 11:59pm on December 23, 2021.

The University accepts no responsibility for any problem of access, impediment, dysfunction or difficulty regarding technical instruments, the computer, the telephone line, transmission and connection, or the Internet connection that may prevent participation in this initiative, for causes beyond its control.

5. Purpose

The Department of Molecular Sciences and Nanosystems organizes the photo contest #CFScienzeMolecolariNanosistemi as part of the orientation and promotion of its courses of study.



The contest aims to identify 5 images representative of the 5 courses of study related to the DSMN with the aim of using them for promotional material and orientation of the courses of study, inviting you to post one or more photos of objects, places, situations representative of the courses of study object of this contest.

We are specifically looking for:

- photos of objects, places, situations that express the intrinsic characteristics of the course of study for which you intend to participate;
- original photos with a particular artistic composition.

The Jury will select 5 winning photos (1 per course of study) as explained in point 10 of these regulations.

Please note that portraits cannot be selected: people can be present and appear in the photo only if they are of age, not recognizable and it is clear that they do not represent the main subject of the photo.

6. Photo features

The photos published must be at least 12 megapixels (2848 px minimum size for the short side) to allow for subsequent printing on the presentation material of the course of study as specified in point 10.

No signatures, logos or other graphic symbols should be stamped on the photographs.

7. Target audience

The contest is open to the Ca' Foscari community: students regularly enrolled in courses related to the Department of Molecular Sciences and Nanosystems at the date of the contest:

- degree course in Science and Technology for Cultural Heritage - university code CT60
- degree course in Sustainable Chemistry and Technology - University code CT7
- degree course in Physical Engineering - University code CT8
- Master's degree course in Chemistry and Sustainable Technologies - University code CM7
- Master's degree course in Science and Technology of Bio and Nanomaterials - University code CM12

8. Contest result

The outcome of the contest will be announced from January 27 2022 on the Instagram profile @[dip.scienzemolecolari](https://www.instagram.com/dip.scienzemolecolari) and on the Department of Molecular Sciences and Nanosystems website.

9. How to participate



To take part in the contest, simply post up to a maximum of 3 photos (post not story) on your Instagram profile indicating in the caption the following tags and hashtags accompanied by the name of the course of study in which you are enrolled and for which you want to compete:

You must have an open Instagram profile.

By posting the photo with the hashtag #CFScienzeMolecolariNanosistemi the participant declares to be the author and owner of the published photograph.

All works must be original and completely unpublished up to the date of the jury's selection and must not have participated in any other competition that may provide for future publication.

Ca' Foscari declines any responsibility for the improper use of the hashtag #CFScienzeMolecolariNanosistemi. It is forbidden for participants to use the hashtag to publish photos that are detrimental to the decorum of the University and of third parties and/or with purposes other than those indicated in these regulations.



10. Conditions of participation

- a) By submitting a contribution to the contest, the participant implicitly authorizes Ca' Foscari University Venice and its assignees to reproduce, display, publish and disseminate the contribution in any medium for promotional and communication purposes and for activities related to the University's institutional aims, in any case on a non-profit basis. Ca' Foscari University Venice will use the aforementioned contribution for the management and execution of the contest and for institutional, promotional and communication purposes of the University, in whole or in part, without any limit of space and/or territory. This implicit authorisation includes the use of the photos sent also for publication on the Internet and social networks, inclusion in other publications, including publications by third parties. No remuneration will be paid for the publication/exhibition/series production of the contribution, but only the prize as per point 13 in case of victory. Each time they are used, the photos will be accompanied by the name of the author;
- b) the contest participant, by submitting his/her contribution, implicitly authorizes Ca' Foscari University Venice and its assignees to process his/her personal data in accordance with EU Regulation 2016/679 and, to the extent applicable, Legislative Decree no. 196 of 30 June 2003. The winners of the contest will also have to give express consent to the processing of their personal data, pursuant to the aforementioned regulations, as well as document the express consent of those who may be represented in the winning photo;
- c) The participant in the competition declares and guarantees that the publication of the contribution is legitimate in that he/she expressly declares and guarantees - answering personally and in full in the event of a false declaration - that the third parties depicted therein have been duly informed by the participant regarding the relative processing of data carried out by the University, and the use that will be made of the contribution sent for participation. The participant declares and guarantees that he/she has obtained all the necessary consents, authorisations and releases for the use (see letter a. above), of the contribution, of the image, of the name and of the exhibition of any subject represented and/or mentioned in the contribution itself;
- d) Contestant represents that the entry: (i) is not obscene, defamatory, insulting, blasphemous, offensive or untrue; (ii) does not promote or incite racial or religious hatred or homophobia or any other form of hatred, violence and discrimination; (iii) does not violate the rights of any natural or legal person, including, without limitation, intellectual and/or industrial property rights, the rights to legitimate data processing, the right to name and



image; (iv) does not offend or damage the reputation or honour of Ca' Foscari University of Venice or any other natural or legal person; (v) does not show dangerous activities involving a risk of injury to the participant in the competition or any other natural or legal person; (vi) does not otherwise violate any applicable law.

11. Exclusions

Will not be considered photos published after the deadline and different from the provisions of this Regulation, in particular depicting people under the age and / or people who represent the main subject of the photo.

The organizers also reserve the right to exclude from the competition and not publish photos that do not conform in form and subject to the commonly recognized rules of public morality, ethics and decency, for the protection of participants and visitors.

Therefore, images considered offensive, improper and harmful to human and social rights will not be admitted.

The participant in the competition agrees to indemnify and hold harmless Ca' Foscari University of Venice and its assignees from any claim and/or action by third parties that they may suffer as a result of violation of the provisions of these Regulations.

12. Jury and identification of winners

The Jury will be composed of the 5 Coordinators of the Degrees courses and 5 members of the Orientation Commission of the Department of Molecular Sciences and Nanosystems and will have the task of selecting the 5 best photos according to the criteria indicated in point 5 above.

The composition as well as all decisions and judgments of the jury are final and unquestionable. The Jury will draw up a ranking up to the third position and will draw up a report of the awarding of prizes, containing the names of the winners as well as the reasons for the awarding of prizes.

Winners will be contacted after January 27, 2022 through Instagram direct. They will be asked to send a first and last name to didattica.dsmn@unive.it, including in the subject line Contest #CFScienzeMolecolariNanosistemi.

The winners must respond within 48 hours of receiving the message, under penalty of exclusion from the contest. In the event that the winners do not respond within 48 hours, the jury will identify another winner, in the order of the list already drawn up.

At any time the Jury may contact through Instagram direct or email the contest participants to ask for additions or clarifications on the published photo.



If the user does not respond to the communications within 48 hours of receipt of the message will be automatically excluded from the winners. The jury will only select photos published between December 1, 2021 and December 23, 2021.

If the photos received do not meet the requirements, the Jury may decide at any time to select a smaller number of photos and/or not to select any.

13. Awards

Prizes will be awarded to the top 5 winners, one from each course in the Department of Molecular Sciences and Nanoasitemns, nominated by the Jury.

Prizes up for grabs:

- 5 Ca' Foscari branded sets, each consisting of a canvas bag and an official University mug + an original and distinct object for the course of study, created specifically for this contest by skilled craftsmen.

14. Publicising the Regulation

15. Photo Properties

All rights to the original photos remain with the author, who is personally responsible for the submitted works.

Each author retains ownership of the photos submitted, but transfers the rights of use of the images free of charge to Ca' Foscari University Venice, which may dispose of them as specified in point 10 above.

16. Liability

Participation in the contest implies express acceptance of these regulations in all their parts.

Each participant is responsible for the content of his photo and guarantees to be the author of the same as well as to claim all rights of use and exploitation of the material sent for the contest. Failing this, the participant will be excluded from the contest. If the photos submitted are not created by the participant and the participant does not hold all rights of economic use, the participant shall indemnify and hold harmless Ca' Foscari University Venice and its assignees from any claim, including compensation for damages, that may be made by the author or owner of such rights or by third parties having such claims.

Ca' Foscari University Venice is not responsible in any way for any claims for compensation made by any person who may be portrayed or by persons with parental responsibility for minors who may, in



any case, appear in the photos: therefore, by accepting these regulations, the Ca' Foscari University of Venice and its assignees are released from all liability in this sense.

The participant, by joining the contest, gives Ca' Foscari University of Venice the right to use (including for promotional purposes), modify, reproduce even partially, disseminate (by any means permitted by technology and in the manner it deems appropriate), distribute, prepare derivative works, display and disseminate in any format and through any channel the photos submitted to the competition, even if combined with their own image, as specified above in paragraph 10.

The participant guarantees Ca' Foscari University of Venice and its assignees the peaceful enjoyment of the rights to the submitted images in accordance with point 10.

Consequently, the participant himself/herself will indemnify and hold harmless Ca' Foscari University of Venice and its assignees from any request for compensation or injunction that may be made by anyone, as well as from all damages and expenses, including legal ones, resulting from alleged infringement of third party rights for which he/she is responsible. Ca' Foscari University Venice and its assignees cannot be held responsible in any way for the use that third parties may make of the photos downloaded from the sites with domain unive.it.

The participant will be obliged to indemnify Ca' Foscari University of Venice from any prejudicial consequence deriving from the use by the University of the images posted, including any legal expenses, even out of court, if the images violate the rights of third parties.

Each participant is civilly and criminally responsible for his or her own works, relieving the organizers of all responsibility, including towards any subjects depicted in the photographs, despite the prohibitions placed by these Regulations. The participant must inform any interested parties in the cases and in the manner provided for by art. 13 GDPR (General Data Protection Regulation) 2016/679 and, to the extent applicable, by Legislative Decree 30 June 2003 n.196, as well as obtain consent to the dissemination of the same.

Under no circumstances may the images posted contain data that can be qualified as 'sensitive' or 'special' under current privacy legislation.

Each participant declares that he/she owns all rights to the originals, digital acquisitions and processing of the photographs submitted and is responsible under and for the purposes of Articles 13-14 of the GDPR (General Data Protection Regulation) 2016/679 for the processing of personal data in accordance with the Regulation.

17. Final rules

For all matters not provided for herein, express reference is made to the relevant laws, the Statute and the University regulations.



INFORMATION ON THE PROCESSING OF PERSONAL DATA

Pursuant to Article 13 of Regulation (EU) 2016/679

Ca' Foscari University of Venice, within the scope of its institutional purposes and in compliance with the obligations provided for in Article 13 of the EU Regulation 2016/679 ("Regulation"), provides you with information regarding the processing of personal data you have provided to the University for the purpose of carrying out the selection procedure in which you intend to participate.

1. DATA CONTROLLER

The Data Controller is Ca' Foscari University of Venice, with registered office in Dorsoduro n. 3246, 30123 Venice (VE), in the person of the Magnificent Rector.

2. DATA PROTECTION OFFICER

The University has appointed a "Data Protection Officer", who can be contacted by writing to the email address dpo@unive.it or to the following address: Università Ca' Foscari Venezia, Data Protection Officer, Dorsoduro n. 3246, 30123 Venezia (VE).

3. CATEGORIES OF PERSONAL DATA, PURPOSE AND LEGAL BASIS OF PROCESSING

The processing in question involves the provision of personal data and category of membership within the university community.

In order to participate, it is not necessary to provide data of a sensitive nature (for example, relating to health, sexual orientation or political or trade union opinions).

Personal data will be processed solely for the purpose of carrying out the selection procedure and will be processed in the manner and within the limits necessary for that purpose.

The legal basis for such processing is Article 6.1. letter e) of EU Regulation 2016/679 ("*performance of a task carried out in the public interest or in connection with the exercise of official authority*"), as well as Article 6.1. letter a) of EU Regulation 2016/679 ("*consent to the processing of one's personal data for one or more specific purposes*").

The processing of personal data is based on the principles of correctness, lawfulness and transparency and the protection of confidentiality and the rights of the data subject, as well as the further principles provided for in Article 5 of EU Regulation 2016/679.

4. MODE OF TREATMENT



The processing of personal data will be carried out by authorized persons (in compliance with the provisions of Article 29 of EU Regulation 2016/679), with the use of procedures including computerized, adopting technical and organizational measures adequate to protect them from unauthorized or illegal access, destruction, loss of integrity and confidentiality, even accidental.

5. STORAGE TIMES

Data will be retained in accordance with the rules on the retention of administrative records.

6. RECIPIENTS AND CATEGORIES OF RECIPIENTS OF PERSONAL DATA

For the above purposes, in addition to specifically authorised employees and collaborators of the University, personal data may also be processed by subjects carrying out activities in outsourcing on behalf of the Data Controller, in their capacity as external Data Processors.

No further communication to third parties is envisaged, except to subjects to whom the data must be transmitted in fulfilment of legal obligations or, on request, to judicial and control bodies.

7. RIGHTS OF THE INTERESTED PARTIES AND HOW TO EXERCISE THEM

As a data subject, you have the right to obtain from the University, in the cases provided for by the Regulations, access to your personal data, rectification, integration, deletion or restriction of processing, or to object to the processing thereof (Articles 15 et seq. of EU Regulation 2016/679). The request may be made, without any formality, by contacting the Data Protection Officer directly at dpo@unive.it or by sending a communication to the following address: Università Ca' Foscari Venezia - Data Protection Officer, Dorsoduro 3246, 30123 Venezia. Alternatively, you may contact the Data Protection Officer by writing to PEC protocollo@pec.unive.it.

Data subjects, who believe that the processing of personal data relating to them is in breach of the provisions of EU Regulation 2016/679, also have the right to lodge a complaint with the Supervisory Authority for the protection of personal data, as provided for by art. 77 of the Regulation itself, or to take legal action (art. 79 of the same Regulation).
